**AND UPON** reading the second affidavit of Margot MacInnis, sworn on 20<sup>th</sup> March 2015 and the affidavit of Alyson Reilly, sworn on 20<sup>th</sup> March 2015

**AND UPON** no objection having been received by the Joint Official Liquidators from any member of the liquidation committee of the Company to the orders sought in the Summons

**AND UPON** reading the letter from counsel for the Joint Official Liquidators dated 19<sup>th</sup> March 2015

**IT IS ORDERED AND DIRECTED THAT**


1. Pursuant to CWR O.5, r.4:
  - 1.1. Ms Margot MacInnis, of Suite 731, 10 Market Street, Grand Cayman be released from the performance of any further duties as Joint Official Liquidator of the Company in light of her resignation from Krys Global and having confirmed her resignation from her appointment effective from the date of this Honourable Court's Order upon this summons, without the need for any report or accounts to be prepared; and
  - 1.2. Ms Alyson Reilly (telephone +1 345 947 4700; email [Alyson.Reilly@KRYs-Global.com](mailto:Alyson.Reilly@KRYs-Global.com)) of Krys Global, Governors Square, Building 6, 2<sup>nd</sup> Floor, 23 Lime Tree Bay Avenue, PO

Box 31237, Grand Cayman, KY1-1205, Cayman Islands, be appointed as successor to Ms MacInnis as joint official liquidator, with power to act jointly and severally with Messrs Borrelli and Chan.

2. In accordance with CWR O.5, r.3(a) notice of the appointment of Ms Reilly be published in the Cayman Islands Gazette and the requirement at CWR O.5, r.3(b) for further publication be dispensed with.
3. No order as to costs.

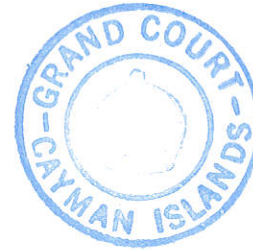
