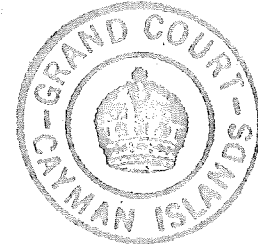

**IN THE MATTER OF THE COMPANIES LAW (2013 REVISION)
AND IN THE MATTER OF SUNTECH POWER HOLDINGS CO., LTD. (IN PROVISIONAL
LIQUIDATION)**

ORDER

UPON the Summons of Messrs David A.K. Walker and Ian Stokoe as joint provisional liquidators ("JPLs") of Suntech Power Holdings Co., Ltd. (in provisional liquidation) (the "**Company**") dated 25 April 2014

AND UPON reading the First, Supplemental and Second Reports of the JPLs and the Fourth Affidavit of David A.K. Walker and the exhibit thereto

AND UPON hearing Counsel for the JPLs


IT IS ORDERED that:

- 1 The JPLs' remuneration in the amount of US\$582,023.10 plus disbursements incurred during the period 7 November to 13 December 2013 be approved and paid out of the assets of the Company.
- 2 The JPLs' remuneration in the amount of US\$552,535.20 plus disbursements incurred during the period 14 December 2013 to 31 January 2014 be approved and paid out of the assets of the Company.
- 3 The JPLs' remuneration in the amount of US\$658,086.90 plus disbursements incurred during the period 1 February 2014 to 31 March 2014 be approved and paid out of the assets of the Company.

- 4 Further to the Order of 31 January 2014, the JPLs be authorised to draw down the remaining balance of the loan from Suntech America, Inc. pursuant to and in accordance with the terms of the Loan Agreement dated 24 January 2014.
- 5 The following sections of the JPLs' Second Report filed with the Court on 28 April 2014 (the "**Second Report**") be redacted, pursuant to Order 24, rule 6 of the Companies Winding Up Rules, 2008:
- 5.1 At section 9.2.1 of the Second Report: the information contained within the 11th and 12th sentences, starting on line 12 on page 29 and continuing onto page 30;
- 5.2 At section 9.2.2 of the Second Report: the information contained within the 7th to 10th sentences, between lines 6 and 11 on page 30; and
- 5.3 The 3rd column of the table appearing at section 11.1.1 of the Second Report on page 36.
- 6 The following pages of Exhibit DW-3 to the Fourth Affidavit of David A.K. Walker sworn on 25 April 2014 be sealed and kept confidential, pursuant to Order 24, rule 6 of the Companies Winding Up Rules, 2008:
- 6.1 Pages 7 to 31 and 41 to 106, in their entirety; and
- 6.2 Those sections of the Second Report, exhibited at pages 157 to 222 of Exhibit DW-3, which have been redacted pursuant to paragraph 5 above.
- 7 The costs of and incidental to the Summons be paid out of the assets of the Company as an expense of the provisional liquidation.
