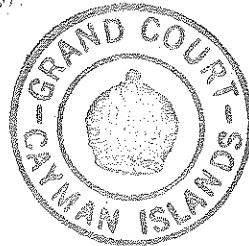

ORDER

UPON the application of Stuart Sybersma and Michael Penner as the Joint Official Liquidators (“JOLs”) of Cedar Lane Entertainment, Ltd. (the “Feeder Fund”) and Cedar Lane Entertainment Fund, Ltd. (the “Master Fund”) by Summons dated 6 May 2014.

AND UPON reading the Fourth Affidavit of Stuart Sybersma sworn on 14 May 2014 and Exhibit “SS3”

AND UPON hearing counsel for the JOLs


IT IS ORDERED AND DIRECTED THAT:

1. The JOLs’ remuneration as liquidators of the Master Fund incurred between 1 April 2013 and 31 March 2014 be approved in the amount of US\$88,282.00 and paid from the liquidation estate of the Master Fund;

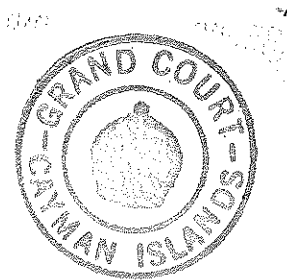
2. The JOLs' remuneration as liquidators of the Feeder Fund incurred between 1 April 2013 and 31 March 2014 be approved in the amount of US\$637.50 and paid from the liquidation estate of the Feeder Fund;
3. The JOLs shall prepare and file a report to the Court in relation to the progress of the winding up of the Master Fund and Feeder Fund in the period from 1st April 2014 to 31 March 2015 as soon as possible after 31st March 2015 and annually thereafter; and,
4. The JOLs' costs of this application be paid from the liquidation estate of the Master Fund as an expense of the liquidation.
