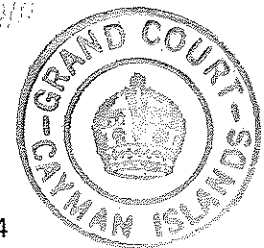

**UPON THE SUMMONS** dated 14 May 2014

**AND UPON** reading the Twenty-Second Affidavit of Geoffrey Varga dated 16 May 2014

**AND UPON** hearing Counsel for the joint official liquidators ("JOLs") of Bear Stearns High-Grade Structured Credit Strategies (Overseas) Ltd. (the "HG Fund")

**IT IS HEREBY ORDERED** that:-

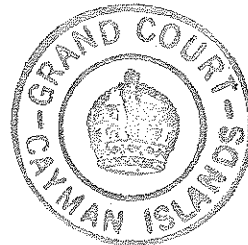
1. Sanction be granted to the JOLs pursuant to s. 110 of the Companies Law (2013 Revision) and Schedule 3, Part 1, paragraph 8 and 9 to enter into Credit Agreements substantially in the form exhibited to the Twenty-Second Affidavit of Geoffrey Varga dated 16 May 2014 (the "Varga Affidavit").
2. Sanction be granted to the JOLs pursuant to s. 110 of the Companies Law (2013 Revision) and Schedule 3, Part 1, paragraph 9 to enter into Security Agreements which will be substantially in the form of that exhibited to the Varga Affidavit, duly amended to reflect the terms of the Credit Agreements entered into pursuant to paragraph 1 of this Order.
3. Sanction be granted to the JOLs pursuant to s. 110 of the Companies Law (2013 Revision) and Schedule 3, Part 1, paragraph 8 and Order 25 r.2(1) of the Companies Winding Up Rules 2008 (as amended) to remunerate Reed Smith LLP as foreign lawyers in accordance with the terms of the engagement letter and addendum exhibited to the Twentieth Affidavit of Geoffrey Varga dated 25 October 2013.
4. Sanction be granted to the JOLs pursuant to s. 110 of the Companies Law (2013 Revision) and Schedule 3, Part 1, paragraphs 8 and 11 to enter into the engagement letter with FTI Consulting Inc. exhibited to the Varga Affidavit.

5. Sanction be granted to the JOLs pursuant to s. 110 of the Companies Law (2013 Revision) and Schedule 3, Part 1, paragraphs 8 and 11 to enter into the Introducer's Fee Agreement exhibited to the Varga Affidavit.
6. Costs of the application be costs in the liquidation of the HG Fund.
