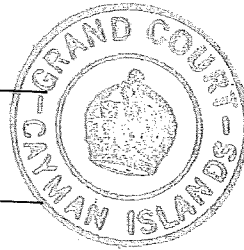

ORDER



UPON hearing the Summons issued by the Joint Official Liquidators ("JOLs") of Focus Management Inc (in Official Liquidation) ("Company") dated 29th May 2014

AND UPON reading the Seventh Affidavit of Hugh Dickson sworn on 2nd June 2014 and the exhibit thereto

AND UPON hearing Counsel for the JOLs

IT IS ORDERED THAT:

1. the JOLs do have sanction pursuant to section 110 of the Companies Law (as revised) to:
 - (i) enter into an agreement with Vanacour Schuler Zarin PLLC in substantially the same form as that set out in tab 10 of exhibit HD7 to the Seventh Affidavit of Hugh Dickson sworn on 2nd June 2014; and

- (ii) continue the proceedings commenced against BNP Paribas (Bahamas) Limited (in voluntary liquidation) and others in the Supreme Court of the Bahamas under cause number 2013/COM/gen/1834 up to the conclusion of the discovery process;
2. the payment out of the assets of the Company of the fees of the JOLs incurred between 1st July 2013 and 31st December 2013 is approved pursuant to section 109 of the Companies Law (as revised) and the Insolvency Practitioners Regulations 2008 in the following amounts:



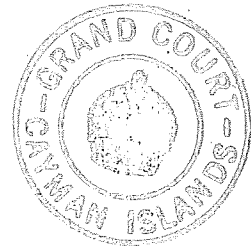
Raymond Chabot Grant Thornton: CA\$ 60,737.50

3. the JOLs are directed to file in Court an updated report setting out the status of the liquidation of the Company as at 30th September 2014 and to apply for the approval of their fees as soon as reasonably practicable thereafter;
4. The JOLs be entitled to their costs of and occasioned by this application to be paid out of the assets of the Company.
