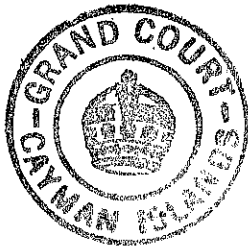
STATEMENT OF CLAIM

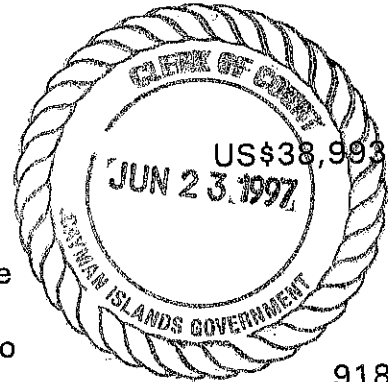

2. The agreement for the said loan entered into at a time when the Defendant was employed by the Plaintiff and/or other BCCI Group entities is evidenced by a Memorandum from BCCI Human Resources Division to General Manager BCCI Africa II Region dated July 26, 1985.
3. By letters dated April 17, 1997 and May 22, 1997 the Official Liquidators of the Plaintiff made demand on the Defendant for the payment of the sum of US\$38,993.19 due and owing as at December 31, 1996 by the Defendant to the Plaintiff in respect of the aforesaid indebtedness.
4. The Defendant has failed to pay the whole or any part of the sum due to the Plaintiff and interest thereon has continued to accrue at the rate aforesaid.
5. The Plaintiff further claims interest on the said amount due at the rate aforesaid from June 23, 1997 to judgment or sooner payment (the daily rate being US\$5.28).

AND THE Plaintiff claims:

1. US\$39,911.91 or CI\$33,526.00 (conversion rate is at US\$1.00 = CI\$.84).
2. Interest as aforesaid.
