

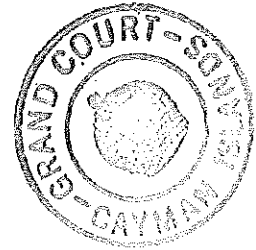

ORDER

UPON hearing Counsel for the Trustee's Agents on their application for directions filed on 18 July 2014

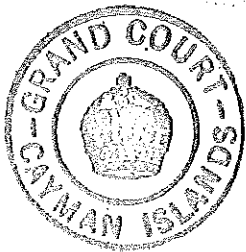
AND UPON hearing Mr. William Millard personally upon his application by e-mail received on 25 July 2014 for additional directions

AND UPON Counsel for the Trustee's Agent undertaking to assist Rued Winkler Partners Ltd and Mr Malcom Davies-White QC to prepare and file applications for taxation of their respective bills of costs

IT IS ORDERED AND DIRECTED that:

1. Within 7 days of the date of this Order, (a) Messrs Kenneth Krys and Margot MacInnis of KRyS Global shall deliver up to William Millard and Patricia Millard ("the Millards") all the documents held in their possession, custody or control in their capacities as the former Trustee's Agents and/or the official liquidators of the companies listed in the Schedule to this Order ("the Companies" and "the JOLs") and (b) Broadhurst LLC shall deliver up to the Millards all the documents held in their possession, custody or power in their capacity as the attorneys for the Millards and/or the former Trustee's Agents and/or the JOLs. For the purposes of this Order the expression "documents" shall include all documents and communications which have been generated, received or held by them electronically.

2. Within 7 days of the date of this Order, the Trustee's Agents are to provide the Millards with a consolidated balance sheet in respect to the estates of William Millard, Patricia Millard and the Companies. The consolidated balance sheet shall include a list of all the property belonging to the Millards and/or the Companies which is in the possession, custody or control of Trustee's Agents or the JOLs or Broadhurst LLC as at the date of this Order.
3. Notwithstanding paragraph 5 of the Order made on 10 December 2013, Rüd Winkler Partners Ltd (Swiss lawyers) and Malcolm Davies-White QC (English counsel) shall file applications for taxation of their respective bills of costs for the period after 31 December 2013 within 7 days from the date of this Order.
4. The bills of costs of Broadhurst LLC and any other attorneys or foreign lawyers retained by the Trustee's Agents and/or the JOLs relating work done after 31 December 2013, shall be taxed in accordance with paragraph 5 of the Order dated 10 December 2013, except that each bill of costs must be served on the Trustee's Agents and the Millards within 7 days of the date of this Order.
5. The Trustee's Agents shall make an application to the Court for approval of their remuneration in their capacities as Trustee's Agents and JOLs of the Companies, on a consolidated basis, for the period subsequent to 31 December 2013. The procedure shall be as follows:




- a. the Trustee's Agents shall prepare consolidated reports and accounts in respect of the estates of both Debtors and the Companies for the period subsequent to 31 December 2013 (the "Consolidated Accounts");
- b. the Consolidated Accounts shall be provided to the Millards, by e-mail or any other means, within 7 days of the date of this order;
- c. the Millards shall insert their objections (if any) into the column of the Consolidated Accounts headed "Objections" and return the completed Consolidated Accounts, along with any statement of objections they might wish to prepare, to the Trustee's Agents within 42 days of being provided with the Consolidated Accounts;
- d. the Trustee's Agents shall file their application for approval of their remuneration, together with the completed Consolidated Accounts and any response to the objections raised by the Millards, within 7 days of receipt of the completed Consolidated Accounts from the Millards.
- e. the application for approval of the Trustee's Agents' remuneration

shall be set down for hearing on the first mutually convenient date after 6 October 2014.

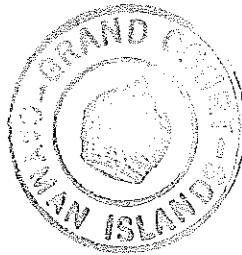
6. The bills of costs required by this Order to be taxed (pursuant to Rule 55 of the Bankruptcy Rules and/or CWR Order 25, rule 2) shall be taxed by the Judge.
7. Liberty to both parties to apply for further or other directions.
8. The costs of this application shall be reserved.
