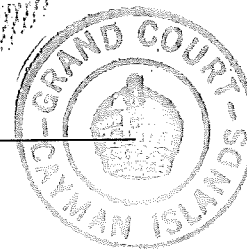

ORDER FOR DIRECTIONS



UPON the application of Zukiapa Management Limited (the **Petitioner**) by summons issued on 30 July 2014 and upon the application by the Petitioner and Company for directions in respect of the winding up petition presented on 23 June 2014

AND UPON hearing Leading Counsel for the Petitioner and counsel for Mertal Overseas S.A. (“**Mertal**”), the Company’s sole shareholder, opposing the winding up petition

AND UPON the Company not appearing by counsel or otherwise being represented at the hearing

IT IS HEREBY ORDERED THAT:

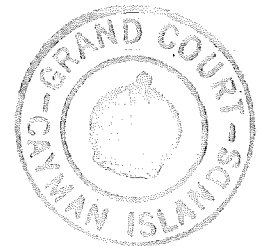
1. If so advised, the Petitioner’s application for leave to amend the winding up petition shall be heard in chambers on 13 August 2014 at 10.00am.

2. The hearing of the winding up petition (or the winding up petition as amended) shall be advertised in the *Cayman Islands Gazette* and the *Swiss Official Gazette of Commerce* (in both French and German language) no later than 25 August 2014.
3. Any further affidavit evidence on which the Company or Mertal intends to rely shall be filed and served no later than 13 August 2014.
4. Any affidavit evidence in reply on which the Petitioner intends to rely shall be filed and served no later than 27 August 2014.
5. The Petitioner's skeleton argument shall be filed and served no later than 27 August 2014.
6. The skeleton arguments of the Company (if any) and Mertal shall be filed and served no later than 29 August 2014.
7. The winding up petition shall be heard on 3 September 2014 at 10.00am with a time estimate of 1 day.
8. The costs ordered to be paid by the Company pursuant to paragraph 7 of the Order made on 17 July 2014 shall be payable forthwith, to be taxed if not agreed.
9. The costs of this application shall be costs in the Petition.
10. Any application for an order for the costs of this hearing to be made by or against Mertal shall be heard at the hearing of the winding up petition.
