UPON reading the Supervision Petition (the "Petition") issued on 14 August 2014 by Hugh Dickson of Grant Thornton Specialist Services (Cayman) Limited and David Bennett of Grant Thornton Recovery & Reorganisation Limited in their capacity as the joint voluntary liquidators (the "JVLs") of TYG Capital Fund (in Voluntary Liquidation) (the "Company")

AND UPON reading the Summons for Directions (the "Summons") issued on 14 August 2014 by the JVLs

AND UPON reading the first affidavit of Hugh Dickson sworn on 14 August 2014

IT IS ORDERED THAT:

1. The Petition shall be listed to be heard on Friday 5 September 2014 at 10:00am (Cayman time).
2. The Petition shall be served on the Company, ~~TYG Investment Management~~ TYG Capital Management (the sole voting shareholder of the Company) and the Cayman Islands Monetary Authority.
3. Notice of the hearing of the Petition shall be given by e-mail (at the last known address) to (i) Hilda Hor Yee Chan; (ii) Daren Ka Yip Chan; (iii) the investors and prospective investors of the Company; and (iv) any known creditors or contingent creditors.

4. Notice of the hearing of the Petition in substantially the form as Schedule A to the Summons be published once in the *Cayman Islands Government Gazette*, the *Cayman Compass*, the *South China Morning Post* (in English) and a newspaper having a general circulation in the People's Republic of China (in Mandarin) on or before Monday 25 August 2014.
5. Any member or creditor of the Company wishing to appear and be heard on the question of who should be appointed as official liquidator shall file and serve on the JVLs a notice of appearance.
6. Any further evidence shall be filed at least 3 clear days before the hearing of the Petition.
7. The costs of the Petition shall be reserved.

Any creditor or member of the Company wishing to be heard on the question of (a) whether or not a winding up order should be made or (b) who should act as liquidators of the Company, must give three (3) days' notice to the Company's attorneys of his intention to appear and be heard on the Petition.
