

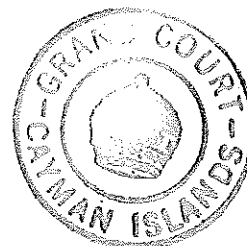

ORDER

THE SUMMONS of Stematix Inc., creditor, filed 29 August 2014 for removal of the Joint Official Liquidators pursuant to s.107 of the Companies Law (2013 Revision), and for directions came on for hearing this day in court;

UPON READING the Joint Official Liquidators' Final Report dated 31 July 2014, the affidavit of David C. Bonner dated 29 August 2014, and the Affidavit and Consent of the Proposed Joint Official Liquidators dated 29 August 2014;

AND UPON hearing from Paul Keeble for Stematix Inc., James Austin-Smith for the Joint Official Liquidators and Guy Dilliway-Parry for Philip Ebanks and Harmonic Health Consultant Ltd;


IT IS HEREBY ORDERED that:

1. Stematix Inc.'s application to remove the Joint Official Liquidators be adjourned.
2. Within seven days counsel for Stematix Inc. is to file:
 - a) Further written submissions setting out what Stematix Inc. wishes the proposed replacement/additional liquidators to do, what actions it wishes them to take, and the proposed terms of and scope of their reference;
 - b) Evidence of the proposed replacement/additional liquidators' willingness to act and of their satisfaction with the arrangements for their funding and that of their attorneys; and
 - c) Draft directions setting out the order that Stematix Inc. wishes the Court to make.
3. Within seven days of receipt of the documents referred to in paragraph 2 above counsel for the Joint Official Liquidators is to file written submissions in response setting out their objections, if any, to the terms of reference etc. proposed and the directions sought by Stematix Inc.

4. Following receipt of the submissions as aforesaid this Court will provide directions for the further conduct of the liquidation, or direct a further hearing in this matter as it considers necessary.
5. Costs reserved.

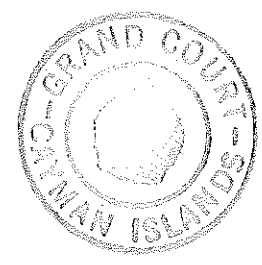

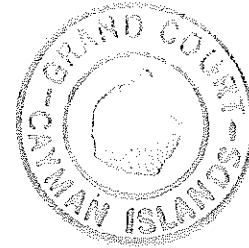
