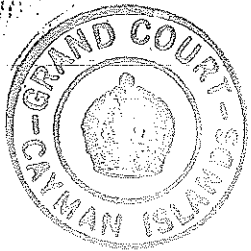
ORDER

  - (b) by personally serving the same, in Sweden, on any one of the following legal representatives of the Company:


