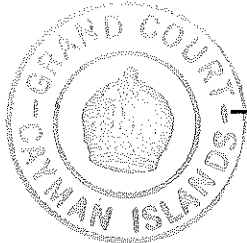

**UPON** the Plaintiffs' applications by its Summons dated 21<sup>st</sup> August 2015 and its Summons dated 9<sup>th</sup> October 2015

**AND UPON** reading the First Affidavit of Ian Stokoe sworn 24 March 2015 and the First Affidavit of Elizabeth Budzynski sworn on 5 October 2015

**AND UPON** reading the skeleton argument lodged on behalf of the Plaintiffs

**AND UPON** hearing Counsel for the Plaintiffs and the present Defendant

**IT IS ORDERED** that:

1. Pursuant to GCR Order 20 Rule 5 (3), leave of the Court be granted to amend the Writ of Summons in this matter as follows:
  - a. To correct the name of the Defendant to "Citco Global Custody N.V."; and

- b. To correct the address of the Defendant to "Telestone 8 – Teleport, Naritaweg 165, 1043 BW Amsterdam, The Netherlands".
2. Pursuant to GCR Order 11, rule 1(1)(ff) the Plaintiffs be granted leave to serve the Writ of Summons out of the jurisdiction on the amended Defendant by:
  - a. Translating a copy of the same into Dutch; and
  - b. Instructing a bailiff to deliver the translated document to the registered office of the amended Defendant.
3. The time for acknowledging service of the Writ of Summons by the amended Defendant be 28 days after the day of service of the aforesaid.
4. There be liberty for the amended Defendant to apply.
5. The Plaintiffs pay the present Defendant's reasonable costs of and occasioned by this application, to be taxed if not agreed.
