ORDER

UPON the application of Eleanor Fisher and Tammy Fu of Zolfo Cooper (Cayman) Limited as Joint provisional liquidators (the "JPLs") of LDK Solar CO., Ltd. (in provisional liquidation) (the "Company") by Summons dated 13 October 2014 (the "Summons")

AND UPON reading the Fourth Affidavit of Eleanor Fisher and Exhibit EF 3 sworn on 15 October 2014 ("Fisher 4")

AND UPON hearing counsel for the JPLs

AND UPON being satisfied that the members of the Company's Liquidation Committee had consented to the Summons being heard on less than 4 clear days' notice

IT IS ORDERED THAT:


1. the JPLs be authorised to cause the Company to enter into, execute and perform a Settlement and Compromise Agreement between Great Lakes Reinsurance (UK) plc, Munich Reinsurance Company, the Company, LDK Solar Europe Holding, S.A., LDK Solar USA, Inc., and Jiangxi LDK Solar Hi-Tech Co. Ltd, and the Escrow Agreement and the Superseding Stipulated Judgment in Schedules 1 and 3 thereto, each in or substantially in the form exhibited to Fisher 4;

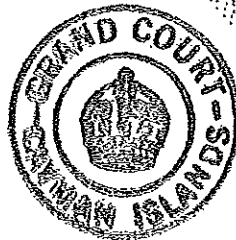
2. the JPLs be authorised to cause the Company to enter into, execute and perform the Amendment to Commitment Letter from Heng Rui Xin Energy (HK) Co., Limited dated 24 September 2014 in the form exhibited to Fisher 4;
3. the JPLs be authorised to cause the Company to enter into, execute and perform the loan agreement between the Company and LDK Solar Systems Inc in the form exhibited to Fisher 4;
4. the JPLs shall provide a copy of Fisher 4 on request to any Scheme Creditor (as defined in the scheme of arrangement proposed in respect of the Company in FSD 97 of 2014 – AJJ); and
5. the JPLs' costs of this application shall be paid as an expense of the provisional liquidation.
