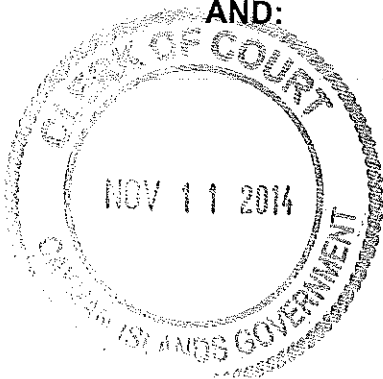

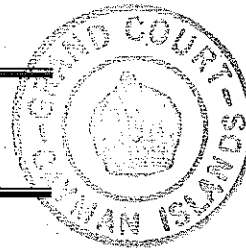

WRIT OF SUMMONS



TO: Westin Casuarina Resort & Spa c/o Cayman First Insurance Company Ltd, 3rd Floor, Harbour Place, 103 South Church Street, P.O. Box 2171, Grand Cayman Ky1-1105, Cayman islands.

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within (14 Days) after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Courts Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment of Service within the time stated, or if you return the Acknowledgement of Service without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and Judgment may be entered against you forthwith without further notice.

NOTE – This Writ may not be served later than 4 calendar months (or, if leave is required to effect service out of the jurisdiction, 6 months) beginning with the date of issue unless renewed by Order of the Court.



GENERAL INDORSEMENT

The Plaintiff's claim is for General & Special Damages to be assessed.

1. On 9th November 2011, our Client was about to clock off work in the Westin Casuarina Resort & Spa Hotel's (the "Defendant"), cafeteria. He was breaking down food trays after the staff lunch and taking them to the kitchen.
2. After completing the process of placing excess food into the freezer, and as he was walking in front of the kitchen stoves, our Client slipped and fell heavily on his side. The culprit was a greasy fluid backing up through the kitchen drain located between the stoves.
3. On 25 November 2011, after numerous visits to the hospital, the Plaintiff was diagnosed with a muscle spasm of the back and a scan showed a small central disc herniation at L4-5 level. After numerous treatments including spinal injections and pain management programs, the Plaintiff is still suffering from severe pain and has been medically described as being unable to work i.e. permanently disabled.
4. The Plaintiffs latest prognosis shows a degenerative disc at L4/5 with annual tear and the Plaintiff is suffering from discogenic and facet joint mechanical pain. There has been a recommendation the Plaintiff should undergo spinal fusion surgery
5. The slip and fall accident was due to the negligence of the Defendant, who caused, permitted, required or suffered the Plaintiff to work as above when it was unsafe to do so. The Defendant breached its duty of care to the Plaintiff by exposing the Plaintiff to a danger or a trap or a foreseeable risk of injury, and failed to take any adequate care for the safety of the Plaintiff.
6. Further the Plaintiff under duress, and without legal advice, was asked to sign a settlement agreement by the Defendant resulting in a minimal payment under the Workmen's Compensation Law.
6. As a result of the above, the Plaintiff has suffered personal injury, loss and damage, and claims;
 - (a) General damages for pain suffering and loss of amenity (to be assessed)
 - (b) Special damages (to be assessed)
 - (c) Pre-judgment interest in accordance with the Judicature Law
 - (d) Post-judgment interest in accordance with the Judicature Law
 - (e) Further and/or other relief; and
 - (f) Costs
7. Such further and other relief as to this Honourable Court may deem just and equitable.

NOTE ON ADDRESS FOR SERVICE

Attorney: Where the Defendant is represented by an attorney, state the attorney's place of business in the Cayman Islands. A Defendant may not act by a foreign attorney.

Defendant in person: where the Defendant is acting in person, he/she must give his post office box number and the physical address of his/her residence or, if he/she does not reside in the Cayman Islands, he/she must give an address in Grand Cayman where communications for him/her should be sent. In the case of a Limited Company "residence" means its registered or principal office.

**DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE OF
WRIT OF SUMMONS**

1. The accompanying form of ***Acknowledgment of Service*** should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion, it must be delivered or sent by post to the Law Courts, PO Box 495, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the Proceedings ***must also serve a Defence*** on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for Judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter Judgment against him without further notice.

3. A ***Stay of Execution*** against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any Judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a Stay, Execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, ***issue a Summons*** for a Stay of Execution, supported by an Affidavit of his Means. The Affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes for Guidance:

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a Writ served on the Defendant personally is treated as having been served on the day it was delivered to him/her.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (*the name stated on the Writ of Summons*)".
4. Where the Defendant is a **FIRM** and an Attorney is not instructed, the form must be completed by a **PARTNER** by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.
5. Where the Defendant is sued as an individual **TRADING IN A NAME OTHER THAN HIS OWN**, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
6. Where the Defendant is a **LIMITED COMPANY** the form must be completed by an Attorney or by someone authorized to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on his behalf.
7. Where the Defendant is a **MINOR** or a **MENTAL PATIENT**, the form must be completed by an Attorney acting for a guardian *ad litem*.
8. A Defendant acting in person may obtain help in completing the form at the Courts Office.
