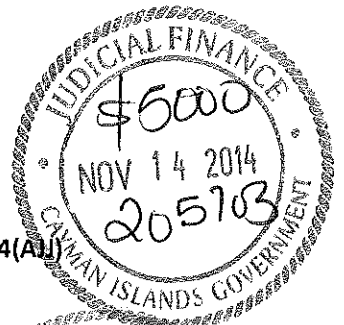

Within fourteen (14) days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495, George Town, Grand Cayman KY1-1106, Cayman Islands, the accompanying Acknowledgment of Service stating therein whether you intend to contest these Proceedings.

If you fail to satisfy the claim or to return the Acknowledgment of Service within the time stated, or if you return the Acknowledgment of Service without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

GENERAL INDORSEMENT

AND THE PLAINTIFF claims:

1 Against the First Defendant

(a) US\$5,673,257.28 being the amount of a judgment debt (in the sum of US\$5,670,869.57 plus costs of £1,920.00 (being US\$2,387.71 at the ECB fixing rate on 14 November 2014 of US\$1.2436 to £1) entered against him by the Plaintiff on 14 November 2014 and obtained from the High Court of Justice, Queen's Bench Division, England & Wales, a judgment on which judgment interest accrues at 1% p.a. above the prevailing US Prime Rate;

(b) Interest from 15 November 2014 to the date of judgment at 1% p.a. above the prevailing US Prime Rate or at such rate and for such period as determined by the Court;

(c) Further and other relief;

(d) Costs.

2 Against the Second to Sixth Defendants

(a) An interlocutory Injunction Prohibiting Disposal of Assets in the Cayman Islands;

(b) Further and other relief.
