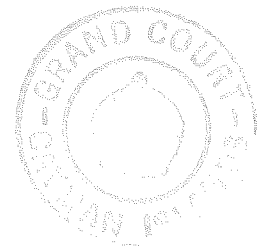

BY CONSENT IT IS ORDERED THAT:

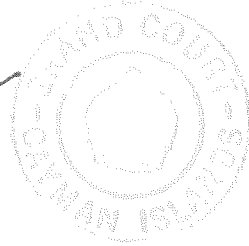
1. The Proceedings are hereby stayed until delivery of judgment at trial of FSD Cause Number 98 of 2014 (NRLC).
