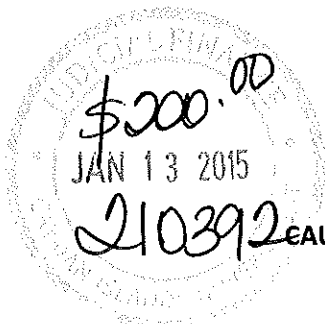

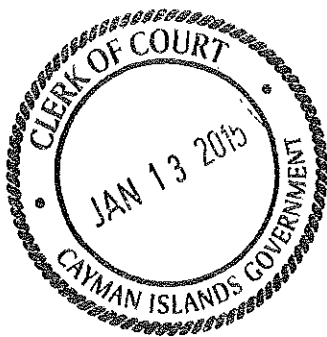

## STATEMENT OF CLAIM

---

### Introduction

1. Each of the Plaintiffs ("P1" to "P3") is connected to Morritt's Resorts (the "Resort Complex"), which refers to four properties comprising a vacation resort in Grand Cayman: Morritt's Tortuga Club ("MTC"), Morritt's Grand Resort ("MGR"), Morritt's Tortuga Seaside ("MTS") and Morritt's Residences ("MR"). Properties within MTC, MTS and MGR typically involve the holding of an interest by individuals as timeshares, whereas properties in MR are owned absolutely. P3 also retains legal interests in MTC, MTS and MGR.
2. Specifically:
  - 2.1. P1 was responsible for developing the Resort Complex through P3, of which he is a member.
  - 2.2. P2 is P1's wife.
  - 2.3. Having developed the Resort Complex, P3 holds the underlying interest in the properties, and therefore has a substantial economic interest in the success of the Resort Complex in regard to sale of timeshare interests, sale of timeshare exchanges, sale of ownership interests and sale of short term accommodation to persons with no timeshare or other legal interest in the resort properties.
3. The defendant ("D") was formerly the owner of a timeshare in an MTC property. Following a number of disputes between D and the Resort Complex management, P3 agreed to buy back D's timeshare. The Plaintiffs' understanding is that D is now returning to MTC each year to stay in a timeshare property owned by Mr. Manfred Lissina, in which he granted her an interest.

### The Statements

4. On a number of occasions, including in October and November 2014 and January 2015, D published numerous statements (a comprehensive version of the statements is annexed to this Statement of Claim) to a Facebook Group entitled "*Morritt's Grand Resort*", the address of which is <https://www.facebook.com/groups/grandresort/members/> ("the Website") and/or

5. At all material times, the Websites were "*public groups*" and could therefore be accessed by any user of the World Wide Web and it is to be inferred that a substantial number of users with a potential or actual interest in the Resort Complex and/or in the Plaintiffs have in fact accessed it and read the words complained of. Without prejudice to the generality of the foregoing, the Plaintiffs will rely in particular upon the following facts and matters:
  - 5.1. The Website has 503 and Friend Website 610 members. These individuals can reasonably be expected to follow discussions on the Websites.
  - 5.2. The Websites appears prominently on a search within the Facebook website for "*Morritt's*", so it is to be inferred that individuals who are not members of the Websites may visit the Websites when trying to ascertain information about the Resort Complex.
  - 5.3. The Websites displays, amongst other things, statements from timeshare owners in which they offer the use of their timeshare to the public for a fee.
  - 5.4. In any event, a number of individuals, including Carol Burke Norcia, Karissa Luran Carpenter, Diana Wight Merrifield and Ann Bynum Patsy, posted replies to the statements, and it is to be inferred that they read the words complained of.

#### **Disrepair and missing funds**

6. During January 2015, on the Website, D published the following words which are defamatory of the Plaintiffs:
  - 6.1. "*11 seasons now....\$10,000,000. to now approximately \$13,000,000. in MFs...And those poolside units are left in disrepair for 20-25 years [...] What IS being hidden? New projects versus Maintenance.....*"
  - 6.2. "*\$13,000,000. approximately and perhaps \$10,000,000., prior, in MF revenue does NOT belong to family. Belongs to the retrospective 2 Associations and those monies should have been used accordingly, for the upkeep of units*"

7. The words complained of referred and were understood to refer to the Plaintiffs, who will rely on the following facts and matters:

7.1. Regarding P3:

7.1.1. The name of the website is "*Morritt's Grand Resort*" and the discussions within which the statements were published refer to the Resort Complex and to individuals whom those acquainted with the Resort Complex would know to be associated with the Resort Complex.

7.1.2. P3 is the owner of the Resort Complex and would be identified by reasonable readers as the subject of the allegations.

7.2. Regarding P1 and P2, the word 'family' is used in several other statements on the Website to refer to P1 and his immediate family (including P2). The only family closely associated with the ownership and management of the Resort Complex is P1's immediate family.

7.3. In the premises it is to be inferred that a large but necessarily unquantifiable number of readers of the words complained of would reasonably have understood them to be referring to the Plaintiffs.

8. In their natural and ordinary meaning, the words meant and were understood to mean that (i) each of the Resort Complex properties was in a state of disrepair; (ii) sums accumulated for repair of the Resort Complex properties have not been used for that purpose; and (iii) such sums have in fact been appropriated by the Plaintiffs.

9. Further or alternatively, the said meaning would be conveyed to a person by reason of knowing the following extraneous facts and matters (which facts and matters would be known to most, if not all, persons visiting the Website) :

9.1. "*MFs*" is an abbreviation of the words "*management fees*".

9.2. The rhetorical question "*What IS being hidden?*" refers to wider (false) allegations made by D that the Resort Complex is embroiled in conspiracy.

9.3. As set out above, the word *"family"* refers to P1 and his immediate family.

**Special assessment**

10. During January 2015, on the Website, D published the following words which are defamatory of the Plaintiffs :

10.1. "No! to a SA is THE most important issue on the table now. No one on either Board will protect. If they do, family will boot them out."

10.2. "Will you 'make noise' Carol Burke Norcia when an SA is implemented?"

10.3. "Special Assessment! Once implemented, no going back....either pay or forfeit!"

10.4. "Enjoy, all, your SA, Special Assessment"

10.5. "preventing an SA is my mission ~ family monies the MFs are not"

11. Further, in or around October/November 2014, on the Friends Website, D published the following words which are defamatory of the Plaintiffs:

*"Who is 'in' for their paycheck.....who is 'in' to protect owners and their investments ~ 'you' decide...who cares? lol....Karma ~ let 'them' then explain the Special Assessment....they are aware of the feast that is 'to come'"*

12. The words complained of referred and were understood to refer to the Plaintiffs, and in that regard paragraphs 6.1 to 6.3 above are repeated.

13. In their natural and ordinary meaning, the words complained of meant and were understood to mean that (i) timeshare owners within the Resort Complex would soon be facing 'special assessment' fees, namely one-off, typically unexpected charges on top of their annual maintenance fees, (ii) one should be wary of the Resort Complex because of the sudden imposition of the fees, and (iii) those fees were necessary because the Plaintiffs were appropriating management fees.

14. Further or alternatively, the said meaning would be conveyed to a person by reason of knowing the following facts and matters (which facts and matters would be known to most, if not all, persons visiting the Website):

14.1. "SA" was being used as an abbreviation for the words *"special assessment"*.

14.2. "MFs" is an abbreviation of the words *"management fees"*

14.3. Special assessment fees carry negative connotations in the timeshare industry, and reflect badly upon the timeshare developer.

14.4. D had made a wide range of allegations against the Plaintiffs on the Website.

#### **Blackmail**

15. During January 2015, on the Website, D published the following words which are defamatory of the Plaintiffs:

15.1. *"Mimi's blackmail via Greg Bissett, IT, backfired as I knew it would. She tried years ago...WHY?"*

15.2. *"blackmail backfired and only promoted more fodder for Gov"*

16. Further, in or around October/November 2014, on the Friends Website, D published the following words which are defamatory of the Plaintiffs:

*"I will always be an advocate, I do not care what 'they' have on me....George knows all....Blackmail only 'hurts' the resort more, each and every one who bought into the 'dream'...Government....hmmmm"*

17. The words complained of referred and were understood to refer to the Plaintiffs and in that regard:

17.1. P1 will rely upon his close connections to P2 and P3.

17.2. P2 is mentioned by name.

17.3. P3 will rely upon paragraph 7.1 above, which is repeated.

17.4. Paragraph 6.3 above is repeated.

18. In their natural and ordinary meaning, the words meant and were understood to mean that (i) P2 had conducted blackmail and (ii) she had done so on behalf of the owners and operators of the Resort Complex.

19. Further or alternatively, the said meaning would be conveyed to a person by reason of knowing the wide range of allegations made by D on the Website, which would be known to most, if not all, persons visiting the Website.

## **Spying and underhand tactics**

20. During January 2015, on the Website, D published the following words which are defamatory of the Plaintiffs:
- 20.1. *"Phone call I made yesterday? My landline, Internet and cell phones still monitored?"*
- 20.2. *"I have known ALL players for up to 20+ years...correct information Anouska, Johnson, Mimi, Directors, David, Greg, Michelle, etc., Shut me up, no way! Keep on keeping on with surveillance of me....."*
- 20.3. *"My FB, etc. was hacked a long time ago ~ you are aware, so is Government and the Police. My house phone, Internet phone and cell phones...,IPad and laptop ~ do you want me to divulge more? Why? Is what we, Government and police want to know."*
21. Further, in or around October/November 2014, on the Friends Website, D published the following words which are defamatory of the Plaintiffs:
- 21.1. *"ANOUSKA MORRITT, CHRISTOPHER JOHNSON, MIMI MORRITT CAPS, WHAT GIVES? I WILL ALWAYS LET OWNERS KNOW WHAT YOU ARE DOING...THEY ASK, I TELL. GOVERNMENT, SAY WHAT YOU WANT, I AM WILLING TO EXPOSE ALL..ANYTHING AND EVERYTHING. HAVE ME MAIMED OR KILLED? ALL KNOW WHO TO GO TO. MIMI SPYING FOR ALL THESE YEARS HAS BEEN TO THE DETRIMENT OF YOUR COMPANY. RETHINK."*
- 21.2. *"All let Mimi know that I have closed my blinds. Spying on me will not occur. Listen to her gossip. Do you want to know what I am wearing or is she letting you know?"*
22. Paragraph 16 above is repeated.
23. In their natural and ordinary meaning, the words complained of meant and were understood to mean that the Plaintiffs spied on D, monitored her telephone and internet use and have sought to prevent her from airing legitimate grievance.
24. Further or alternatively, the said meaning would be conveyed to a person by reason of knowing the wide range of allegations made by D on the Website, which would be known to most, if not all, persons visiting the Website.

## Government investigation

25. During October 2014 and January 2015, on the Website, D published the following words which are defamatory of the Plaintiffs:
- 25.1. *"anyone who is not 'friends' with the proprietors...please review the Cayman Islands Government Commission on Timeshare Reform. This is a country, governed by rules, laws and regulations. Morrirt's is registered here. After all I am 'hearing' about the 'joke' I am, I am leaning towards reopening my 'case' against someone, to have an arrest made....enough is enough."*
- 25.2. *"All need to research Cayman Islands Government of Timeshare Reform. Formed solely due to issues at Morrirt's. Myron, sue me as you are saying you will. I will expose you and Mimi and other issues."*
- 25.3. *"Government is aware of structure of Board and all issues. Ongoing research by them."*
- 25.4. *"Caymanian Compass, CNS News, Cayman 24 and 27, INews, etc. Government IS involved. Solely due to the protection of owners and the unfair use of Government. Family and board?"*
- 25.5. *"Carol Burke Norcia the info you gave me, a couple of weeks ago, is jail time and hefty fine for all involved. Thank you on behalf of all owners and the Government here. NO SA!"*
- 25.6. *"Keep on keeping on, the more you say, the more proof for Government for arrests"*
26. The words complained of referred and were understood to refer to the Plaintiffs, and in that regard paragraphs 7.1 to 7.3 above are repeated.
27. In their natural and ordinary meaning the words complained of meant and were understood to mean that there was a Cayman Government investigation into mistreatment of timeshare owners by the Plaintiffs.

## Malicious falsehood

28. Further or alternatively, the statements set out in paragraphs 6, 10, 11, 15, 16, 20, 21 and 25 constituted malicious falsehoods.

29. The words complained of were false in that:
- 29.1. Refurbishment and renovation is a matter for the companies which accumulate the relevant management fees (not P3). In any event, funds have been spent by those companies on continual renovation and refurbishment of the Resort Complex properties, and no such funds have been appropriated by any of the plaintiffs.
  - 29.2. None of the Plaintiffs intend, or have given any timeshare owners reason to believe that they intend, to levy a special assessment fee.
  - 29.3. None of the Plaintiffs, including P2, has ever been involved in blackmail.
  - 29.4. None of the Plaintiffs has spied on or monitored D. D has no legitimate grievances and the Plaintiffs have not sought to prevent D from airing any legitimate grievance.
  - 29.5. There is no investigation into the treatment of timeshare owners by the Plaintiffs. For the avoidance of doubt, the Plaintiffs have not in fact mistreated timeshare owners.
30. The words complained of were published maliciously, and the Plaintiffs will rely upon the following facts and matters:
- 30.1. D was aware that, by publishing the statements complained of, she would cause damage to the Plaintiffs, in that persons who read the statements would be less likely to stay at a property at the Resort Complex.
  - 30.2. D was reckless as to whether the statements complained of were true or false.
31. The words complained of were calculated to pecuniary damage to the Plaintiffs and the Plaintiffs will rely upon section 4(a) of the Defamation Law (1995 Revision).

### **Loss and Damage**

32. By reason of the publication of the words complained of:
- 32.1. The Plaintiffs' reputations have been seriously harmed.
  - 32.2. P1 and P2 have each suffered considerable hurt, distress and embarrassment.

- 32.3. P3 has suffered and will continue to suffer financial loss through general loss of business as set out in paragraph 34 below.
33. The Plaintiffs will rely on the following facts and matters in support of a claim for damages, including aggravated damages:
- 33.1. Although the Plaintiffs have made it quite clear to D that the words complained of are entirely false and baseless, D has failed to offer any apology or retraction which adequately addresses the harm occasioned by the publication of the libel.
- 33.2. No adequate checks or attempts were made by D to verify the truth of the allegations with the Plaintiffs before publication.
34. Further, P3 has suffered, and will continue to suffer, a general loss of business in that the effect of the statements is to discourage individuals from taking vacations at the Resort Complex. In that regard, P3 will rely upon the following facts and matters:
- 34.1. P3 owns the underlying interest in the Resort Complex properties. A number of the timeshares have not yet been sold and many of the MR properties are not sold. A reduction in demand for the properties affects P3's ability to sell the remaining timeshares and MR units.
- 34.2. P3 attempts to rent unsold timeshares to visitors. Where individuals are discouraged from taking vacations at the Resort Complex its ability to do so is affected.
- 34.3. P3 attempts to attract owners of timeshare interest in other properties to exchange the right they have to spend time at that property for the right to spend time at the Resort Complex. Where individuals are discouraged from spending time on vacation at the Resort Complex its ability to do so is affected.
35. Although D has been excluded from a number of online forums, she continues to find new ways of publishing defamatory and maliciously false statements. Unless restrained by this Honourable Court, D will further publish the words complained of or similar words that are defamatory of the Plaintiffs and maliciously false.

**AND THE PLAINTIFFS CLAIM: -**

1. Damages for libel and/or malicious falsehood, including aggravated damages.
2. An injunction restraining the Defendant whether by herself, her servants or agents or otherwise, from publishing or causing to be published the same or similar words defamatory of the Plaintiffs.
3. Interest as applicable
4. Costs

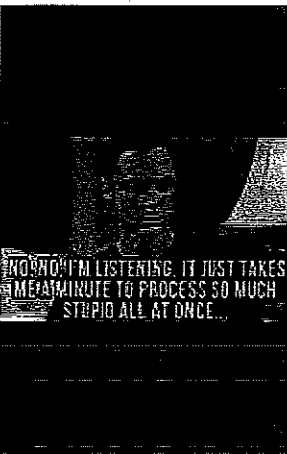

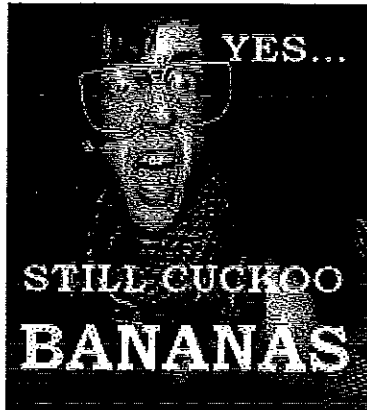

**DIRECTIONS FOR ACKNOWLEDGMENT OF SERVICE**  
**OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgment of Service should be completed by an Attorney acting on behalf of the Defendant or by the Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, P.O. Box 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgment of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is indorsed on the Writ (i.e. the words "Statement of Claim" appear on the top of page 2), the Defence must be served within 14 days after the time for acknowledging service of the Writ, unless in the meantime a summons for judgment is served on the Defendant.

If the Statement of Claim is not indorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgment, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by instalments or otherwise.

## Notes for Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgment of Service and return it to the Courts Office.

For the purpose of calculating the period of 28 days for acknowledging service, a writ served on the Defendant personally is treated as having been served on the day it was delivered to him.

Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".

Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the firm of (.....)" after his name.

Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.

Where the Defendant is a LIMITED COMPANY the form must be completed by an Attorney or by someone authorised to act on behalf of the Company, but the Company can take no further step in the proceedings without an Attorney acting on its behalf.

Where the Defendant is a MINOR or a MENTAL PATIENT, the form must be completed by an Attorney acting for a guardian ad litem.

A Defendant acting in person may obtain help in completing the form at the Courts Office.
