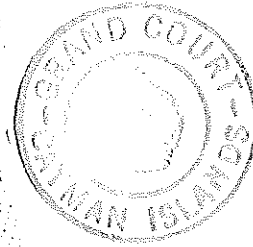

ORDER



UPON hearing Counsel for Matthew Wright and Christopher Kennedy of RHSW (Cayman) Limited in their capacity as the joint official liquidators of Island Taste Limited (In Official Liquidation) ("the JOLs" and "the Company") and Counsel for Mr Kevin Doyle and HRCKY Ltd, creditors of the Company

AND UPON (1) the JOLs' summonses dated 31 July 2014 and 21 August 2014 (together the "Dissolution Summons") seeking an order for dissolution in respect of the Company, (2) the JOLs' summons dated 10 February 2015 for an order that Mr Kevin Doyle pay the JOLs' costs incurred in connection with the report dated 20 October 2014 and prepared by Alyson Reilly and Margot MacInnis of KRyS Global ("the Investigation Report" and "the Additional Liquidators") and (3) Mr Kevin Doyle and HRCKY Ltd's summons dated 13 February 2015 seeking, inter alia, an Order that the Additional Liquidators' costs of and incidental to the Report be paid by the JOLs

AND UPON reading the Investigation Report

AND UPON reading the 5th and 6th Affidavits of Christopher Kennedy sworn on 14 November 2014 and 10 February 2015 respectively with exhibits thereto and filed on behalf of the JOLs

AND UPON reading the 2nd Affidavit of Kevin Doyle sworn on 13 February 2015 and the exhibit thereto



IT IS ORDERED THAT:

1. the JOLs' summons dated 10 February 2015 be dismissed in its entirety.

AND IT IS FURTHER ORDERED in respect of Mr Kevin Doyle and HRCKY Ltd's summons dated 13 February 2015 that :-

1. Paragraph 1 of the Summons is dismissed and the JOLs' remuneration and disbursements in the sums of US\$52,776.50 and US\$1,984.12 respectively be approved and paid out of the assets of the Company.
2. Paragraph 2 is dismissed.
3. The Additional Liquidators shall have power to apply to the Court for an Order approving the assignment of all and any rights and benefits to which the Company may be entitled against Hard Rock Ltd and Hard Rock International to HRCKY Ltd , provided that such application (together with all necessary supporting evidence and a draft deed of assignment) is filed on or before 27 February 2015.


AND IT IS FURTHER ORDERED in respect of the Dissolution Summons that :-

4. The JOLs shall be discharged from the performance of any further duties with immediate effect.
5. The Company shall be dissolved with effect from 28 February 2015.
6. The Additional Liquidators shall be discharged from the performance of any further duties upon the dissolution of the Company.
7. The JOLs and the Additional Liquidators shall preserve their respective liquidation files for a minimum of three years from the date of dissolution of the Company, after which time the JOLs and the Additional Liquidators shall be at liberty to destroy such liquidation files.
8. The Additional Liquidators shall preserve the Company's books and records for a minimum of three years from the date of dissolution of the Company, after which time the Additional Liquidators shall be at liberty to destroy such books and records.

AND IT IS FURTHER ORDERED that there shall be no order for costs as between the JOLs and Mr Kevin Doyle / HRCKY Ltd in respect of each of the three summonses.
