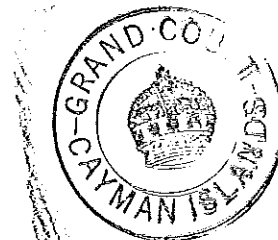

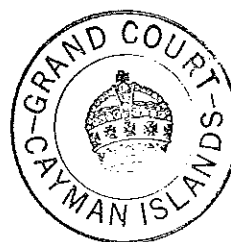
AND UPON hearing counsel for the Plaintiff and for the Defendants


IT IS HEREBY ORDERED that:

This Order is filed by Walkers, Attorneys at Law, for the Plaintiff whose address for service is that of their said attorneys, 190 Elgin Avenue, George Town, Grand Cayman KY1-9001, Cayman Islands.

1. The First Defendant shall provide to the Plaintiff's attorneys complete answers to the questions appearing at paragraph 1 of Part 1 to Schedule 3 of the Order of the Court dated 11 May 2015 (the "Order") by way of affidavit and shall exhibit to such affidavit all supporting documents by 4pm on 29 June 2015;
2. The Defendants shall provide to the Plaintiff's attorneys the remaining information required to be disclosed pursuant to paragraph 2 of the Order by way of affidavit and shall exhibit to such affidavit all supporting documents by 4pm on 6 July 2015;
3. Paragraphs 1(f), 3(f), 4 and 5 of Part I to Schedule 3 of the Order and paragraphs 1(e), 2(f), 4(f) and 5 of Part II to Schedule 3 of the Order be varied such that the Defendants need not produce any documents evidencing single transactions of less than US\$15,000.
4. The Order as varied be extended and do remain in force up to and including the granting of any judgment following a further hearing on 13 July 2015 unless before then it is varied or discharged by a further order of the Court. The application in which this Order is made shall come back to the Court for further hearing on 13 July 2015.
5. The Notice of Motion be adjourned to 13 July 2015.
6. Costs reserved.

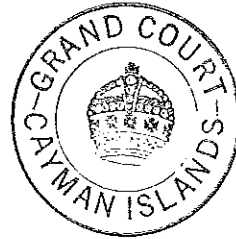
