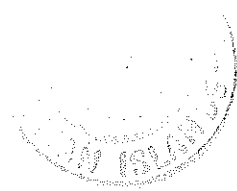

UPON the Joint Official Liquidators (the "JOLs") having filed a Summons dated 28 August 2015 (the "Summons") seeking sanction to exercise their power to sell all of the right, title and interest of Echo Investment Holdings Limited in the entire issued share capital of Landwind Medical Holdings Limited

AND UPON the JOLs having served the Third Affidavit of Cosimo Borrelli and Exhibit CB 2 sworn on 2 September 2015 in support of the Summons

AND UPON the Summons having been listed to be heard on 23 September 2015 (the "Hearing")

AND UPON Mr Ming Fang having confirmed that he does not intend to appear at the Hearing in person or by counsel


BY CONSENT IT IS ORDERED THAT:

1. If IH Services Mauritius II Limited (the "Preferred Shareholder") intends to oppose the Summons then it shall file and serve on the JOLs and TRG Growth Partnership, L.P. and TRG Co-Investment, L.P. (the "Petitioners") evidence setting out its grounds of opposition by 4pm on 9 September 2015.

3. If the Preferred Shareholder does not file and serve evidence in opposition to the Summons in accordance with paragraph 1 above then the JOLs shall consult with the Court regarding the possibility of the Summons being heard on a date earlier than 23 September 2015.
