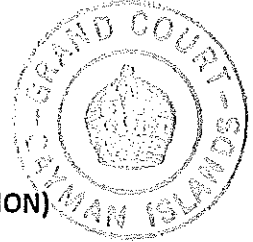

ORDER

UPON the Joint Official Liquidators (the "JOLs") having filed a Summons dated 28 August 2015 (the "Summons") seeking sanction to exercise their power to sell all of the right, title and interest of Echo Investment Holdings Limited (in Official Liquidation) (the "Company") in the entire issued share capital of Landwind Medical Holdings Limited

AND UPON the JOLs having served the Third Affidavit of Cosimo Borrelli and Exhibit CB 2 sworn on 2 September 2015 in support of the Summons

AND UPON the Summons having been listed to be heard on 18 September 2015 (the "Hearing")

AND UPON Dr Ming Fang having confirmed that he does not intend to appear at the Hearing in person or by counsel

AND UPON the Preferred Shareholder having confirmed that it does not intend to oppose the Summons

IT IS ORDERED THAT:

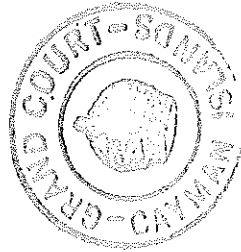
1. the JOLs be authorised, pursuant to section 110(2)(a) of the Companies Law (2013 Revision), to exercise their power to sell all of the Company's right, title and interest in the entire issued share capital of Landwind Medical Holdings Limited on the terms of the draft Deed of Sale attached to the Deed of Undertaking dated 22 April 2015 between TRG Growth Partnership, L.P., TRG Co-Investment, L.P., Dr Ming Fang and Starry Link Holdings Limited;
2. the JOLs' costs of this application be paid as an expense of the liquidation.
