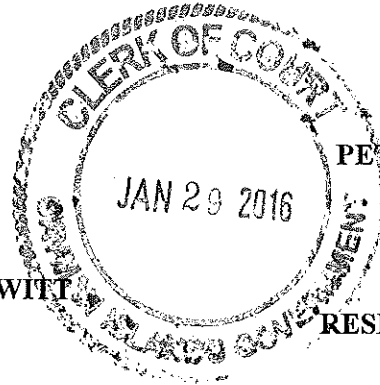
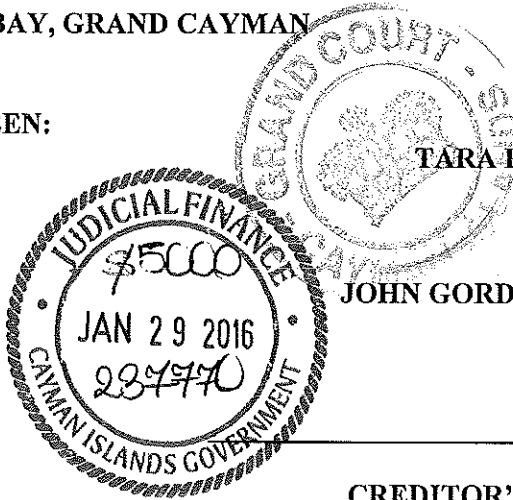

CREDITOR'S PETITION


TO THE GRAND COURT

THE PETITION of TARA RIVERS of West Bay, Grand Cayman sheweth:

1. That John Gordon Hewitt, of Unit No. 27, Ocean Pointe Villas, Andresen Road, West Bay, Grand Cayman, is indebted to your Petitioner in the sum of US\$138,666.79 evidenced by an Interim Costs Certificate dated 25 June 2015 entered by the Clerk of the Court in favour of the Petitioner in Grand Court Cause No. 198/2013.
2. That your Petitioner doth not, nor doth any person or persons in his behalf, hold any security on the said estate of John Gordon Hewitt, or on any part thereof, for the payment of the said sum.
3. That the said John Gordon Hewitt has committed an act of bankruptcy within six months before the presentation of this Petition.
4. That the act of bankruptcy committed by him was that under s.14(h) of the Bankruptcy Law (1997 Revision), namely that the Petitioner on 25 June 2015 obtained final judgment being the Interim Costs Certificate as aforesaid in the total sum of US\$138,666.79 (such Interim Costs Certificate being enforceable as if it were a judgment of Grand Court by virtue of GCR Order 66/22(6)) against the said John Gordon Hewitt in Grand Court Cause No.198/2013, and on 31 July 2015 the Petitioner served on John Gordon Hewitt personally a Bankruptcy Notice dated 29 July 2015 issued by the Clerk of the Court in the form of Form 52 under the Grand Court (Bankruptcy) Rules requiring him to pay the total judgment sum of US\$138,666.79 for which judgment was obtained, and that the said John Gordon Hewitt did not within seven days after service of the said Bankruptcy Notice, pay such amount, or secure or compound for the same to the satisfaction of the Petitioner.

YOUR PETITIONER therefore prays that, on proof of the requisites in that behalf, on the hearing of this petition, the said John Gordon Hewitt may be adjudged bankrupt.
