

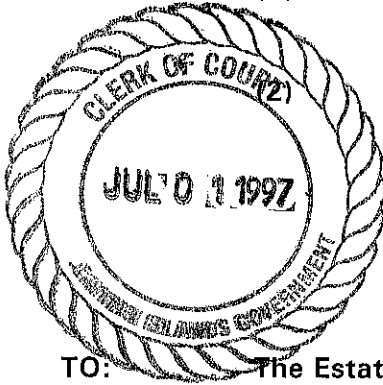

Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

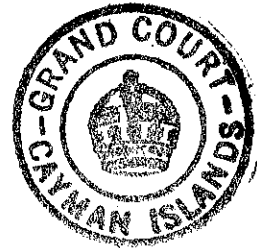

**The Plaintiff's claim is for**

1. Monies owed by the Defendant to the Plaintiff for money lent by the Plaintiff to the Defendant on loan account #01007526 and/or for money paid by the Plaintiff for the Defendant as bankers for the Defendant at his request.
2. Interest at a rate of 9.75% per annum compounded quarterly; alternatively interest on the sum due pursuant to the Judgment Debts (Rates of Interest) Rules 1995 r.4(a); alternatively at such a rate and for such a period as the Court shall deem just.
3. Costs.
4. Further and/or other relief.
