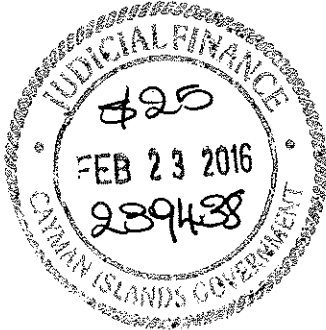

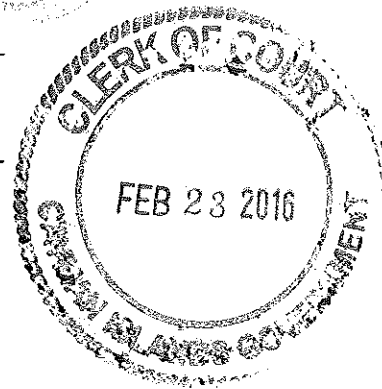

### PARTICULARS OF CLAIM

1. On 12 March 2010 the Defendant requested the services of the Plaintiff (T/a Universal Air-Conditioning) at the Defendant's property located at 27 Trinity Way, North Sound Estates.
2. The Plaintiff was requested by the Defendant to perform diagnostic services on the children bedroom as it was not cooling.
3. The total costs for the Plaintiff's services in relation to the aforementioned was CI\$65.00 and as such invoice no 6859 dated 12 March 2010 was provided to the Defendant.
4. On 30 July 2010 the Defendant requested the services of the Plaintiff. Upon inspection at the property the Plaintiff in agreement with the Defendant a four system maintenance. This included cleaning water from drain pan, replacing batteries in thermostats, checking condensers for leaks, checking the pressures on the condensers, washing the condenser coils, adding drain cleaner and algae tablets, clearing condensate drain lines, checking drain pan for water, inspecting ductwork, checking all electronic components, checking evaporator coil, checking fan motor, replacing and washing filters, inspecting and cleaning all grills, inspecting insulation on the line sets and inspecting thermostat.
5. The total costs for the Plaintiff's services in relation to the aforementioned was CI\$375.00 and as such invoice no 7308 dated 30 July 2010 was provided to the Defendant.
6. On 24 June 2013 the Defendant requested further services of the Plaintiff. The Plaintiff replaced blower 1/3 HP/ 1075 RPM fan motor and capacitor at the Defendant property.
7. The total costs for the Plaintiff's services in relation to the aforementioned was CI\$325.00 and as such invoice no 12746 dated 24 June 2013 was provided to the Defendant.
