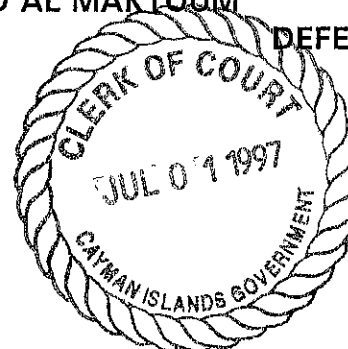

Within 14 days (or such longer period as the Court may specify in granting leave to effect service out of the jurisdiction) after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiffs may proceed with the action and judgment may be entered against you forthwith without further notice.

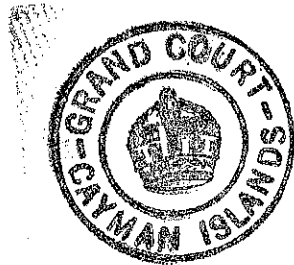
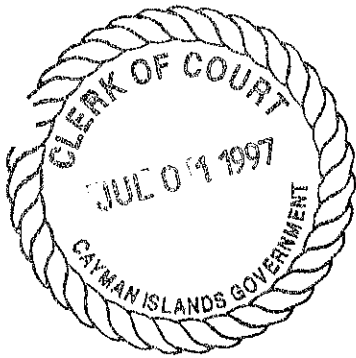

IMPORTANT

Directions for Acknowledgment of Service are given with the accompanying form.

The Plaintiffs' claim is for:-

1. Monies owed by the Defendant to the Plaintiffs for money lent by the Plaintiffs to the Defendant on loan accounts #80488-60 (alternatively account #11001647) and/or for money paid by the Plaintiffs for the Defendant as bankers for the Defendant at his request.
2. Interest at a rate of 1 month US LIBOR + 1.125% per annum compounded monthly; alternatively interest on the sum due pursuant to the Judgment Debts (Rates of Interest) Rules 1995 r.4(a); alternatively at such a rate and for such a period as the Court shall deem just.
3. Costs.
4. Further and/or other relief.
