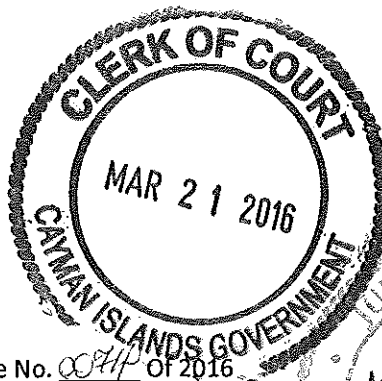


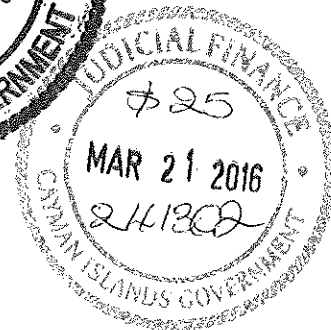

This Pliant has been issued against you by the above-named Plaintiff in respect of, the claim set out on the next page, under the section headed Particulars of Claim.

PARTICULARS OF CLAIM

[Here are set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him]

1] On the 10th of January, 2016, the Defendant agreed to pay all costs arising from an accident that occurred whilst he was driving the vehicle owned by the Plaintiff.

On December 29 2015 the Plaintiff got a text from the Defendant saying "Am trying to call you but I can't get through, give me a number for there." The Plaintiff eventually learned from the Defendant that her car got scratch and that the Defendant would get it fix and also a rent car for the Plaintiff until the car got fix because the Defendant knew the kind of job the Plaintiff does, which is mobile nails. The Plaintiff had given the car keys to the Defendant to fix her car seats and explained to the Defendant not to drive her car. The Plaintiff agreed to him getting her the rental, On December 31 2015 the Plaintiff message the Defendant to find where the car was parked and that she knew a body work man who could fix the scratch on the car for a cheap price, and that the defendant should contact him, but the defendant didn't reply straight up and keep on giving the Plaintiff answer that weren't relevant to the questions that were asked so the Plaintiff told the defendant that she was going to call the police up on telling the Defendant that he then told the Plaintiff that the police is already involved and that they took the car keys from him when there arrested him. The plaintiff asked him what he got arrested for and he didn't reply so she told him there better be a car for me to drive when she arrive from Chicago because the Plaintiff had clients book for the same day. On January 3, 2016. The Plaintiff arrive on island that day she got a voice message from the Defendant saying that a rental car was parked on the side of the road with the keys under the tire, The Plaintiff drove the rental car home then went to my clients after. When the Plaintiff finished working that evening she tried contacting the Defendant to find out some information on the car which he didn't answer after calling and texting over and over with no reply the Plaintiff decided to contact the Defendants sister who told the Plaintiff she knew nothing about the accident and she had the Plaintiff call the Defendants mother who resides in Florida. The Defendants mother told the Plaintiff that "it's her son" and she would help to pay some of the damage to the car.

2] On the 4th of January the Plaintiff call the George Town police station to find out some information on the accident and to also find out where the car was parked the Plaintiff also tried calling the Defendant and again got no reply after calling and messaging numerous times, the police told the Plaintiff that her car was at R&R garage. The Plaintiff went to look at the car and was in shock because my car was totalled. The Plaintiff took pictures and sends them to the Defendants mother and to the Defendant. The Plaintiff went back to the station that evening to talk to the arresting officer who told her to give him a statement and to get estimate. The Plaintiff got the estimate and sends a copy of it to the Defendant and his mother. The Plaintiff asked the Defendant to give her back the money she paid for the estimate, which after another number of calls and messages the Defendant finally meet with the Plaintiff and paid her the \$25 she had paid for the estimate. Also on the 4th of January the Plaintiff went to the company that she have bought her car from, Cayman Leasing because it was on a loan with them, the Plaintiff told Cayman Leasing what happened and showed them photos of the car and the estimate and they told the Plaintiff best thing to do is to have the Defendant come the Plaintiff to sign a contract to continue paying my loan because they knew that insurance wouldn't pay because the Defendant got arrested for DUI

whilst driving the Plaintiff car. Again the Plaintiff tried to contact the Defendant to tell him about what the company said and he ignored her. *Total To fix car is \$16,961.07*

3] The Plaintiff then decided to have the Defendant sign a contract with her to pay all cost surrounding the accident which the Defendant agreed to come and sign at the George Town police station he didn't come the time the Plaintiff told him, but after driving down the Defendant and cussing him out the Defendant eventually came to the station and sign the contact. On January 19 2016 the Plaintiff contacted the Defendant to tell him that she have a friend who would store the car for free and that the Defendant should go to R&R and pay the balance on the car for storage and towing and the Plaintiff would move it to save him from pay storage on the car, the Defendant told the Plaintiff that he would do so. The Plaintiff call R&R to find out if the Defendant had paid the bill they told her the Defendant only paid for the towing of the car. The Plaintiff tried again to contact the Defendant and he continues to ignore her calls and messages. On January 22 the Defendant contacted the Plaintiff saying that he need to talk to her, the Plaintiff made herself available for the Defendant to see her but he didn't show and he only voice notes.

4] On the contract that the Plaintiff had the Defendant sign stated that he should pay her the first installement of \$3000kyd on February 29 2016, the Defendant didn't pay her so the Plaintiff tried contacting him numerous times again and he didn't reply. On my way to the court office to file for her claim the Defendants mother sent me a voice note saying she is asking the Plaintiff give her some time because she filed her tax and as soon as she get the money she would send it to the Plaintiff, which the Plaintiff agreed to wait two weeks, after the two weeks the Plaintiff message the Defendants mother and she didn't reply. The Plaintiff then notice the license on the rental was about to expiry. On March 16, 2016 the Plaintiff contacted both the Defendant and the Defendant mother. The Defendant didn't reply, but his mother reply saying "GE Kerry still waiting these thing take time so iam still waiting, sorry to take so long to respond iam so busy don t have time to scratch my head," by then the Plaintiff decide to go the rental company to find out what to do when she got there they told her that the Defendant owed over \$700 for the rental the Plaintiff was driving and that she should give them the keys. The Plaintiff started crying over the satiation and asked the rental company to take her to pick up her son from pre-school then take her home which they did.

5] The Plaintiff walk to the Defendants house from her house to try to see the Defendant and talk to him about what is happening after trying to contact him via phone, when the Plaintiff got to the Defendant house she saw one of the Defendant friend who she sat with and waited on the Defendant to come home the Plaintiff sat and waited over three hours, then the Defendant drove up when he saw the Plaintiff the Defendant drove off very fast. So the Plaintiff waited another hour after that and then left. The next day the Plaintiff took a taxi to the Defendant work place to try to talk to the Defendants boss about what was going on. When the Plaintiff walk in the office she just started crying because she was so overwhelm with what the Defendant was putting her though and explain that to the Defendant boss what happened he then call the Defendant to come to the office which he came when he got there and realize it was the Plaintiff in the office he walk back out but then his boss call him back to talk to him and advise him to come to some agreement on how is plan to pay me, he told his boss that I said I would take him to court and that I should take him to court so he can tell the judge that he can't pay me and just service is time in jail. His boss told him that's his obligation to pay me, and that he should start paying me, the Defendant then gave me \$50 kyd and said that it was my taxi fare. I took it and left with the intention to take him to court.

6] I therefore would like to ask the court to consider doing detachment of earn because it is obviously that mark don't intent to pay me and thing and as he said he want me to take him to court so he can tell the judge he don't have it to pay me, I also want the detachment or earning done because I have to pay my car loan on the first of every month and right now as I speak I don't have a car to drive around in to do my work I have been without a ride from march 16 2016 and haven't work since. As for the storage of the car it's been 83 day at \$10 per day. I also haven't worked since March 16 2016, when the rental company took back the rental. *Total for car storage is \$830*

AND the Plaintiff claims:

1] The sum of CI\$ 1779.11

2] Interest in the sum of CI\$ ~~18637.93~~ ^{K.O} 42,34 calculated at the prescribed rate from ~~January~~ ^{Dec} ~~10, 2016~~ _{28 15} to date.

3] Fixed costs of CI\$150, alternatively costs to be assessed.

I am the above person and I am providing this statement to Police of my own free will.

I am the sole owner of a silver Nissan Skyline registration 161829. I am the only driver of my vehicle. On December 25th, 2015 I left island to visit Chicago. Prior to leaving I asked my mechanic to whom I know as Mark to drop me to the airport. The reason I ask Mark to drop me to the airport was because his car was parked at my home and I needed him to fix the driver and front passenger seats. I told Mark to fix the car seats and park it at my home at number 74 East Boulevard off Walkers Road. At no time did I give Mark permission to continue driving my car after he was through fixing it. I made arrangements with Mark to get the car seat fix on Monday December 28th, 2015. I tried to get in contact with Mark on the said day but was not getting through. Mark got in contact with me on Tuesday December 29th, 2015 and upon asking what had taken place as I became worried, he informed me that my car got a scratch and he will be renting a car for me for the duration of the time it takes for it to be fixed.

I attended R & R Wrecker Service business location where I was given a bill for over two hundred dollars. I did not pay this bill as it was not mine to do so. I continued to try and contact Mark many times to get my vehicle fix and pay the bill to the wrecker company but he continued to ignore me.
