

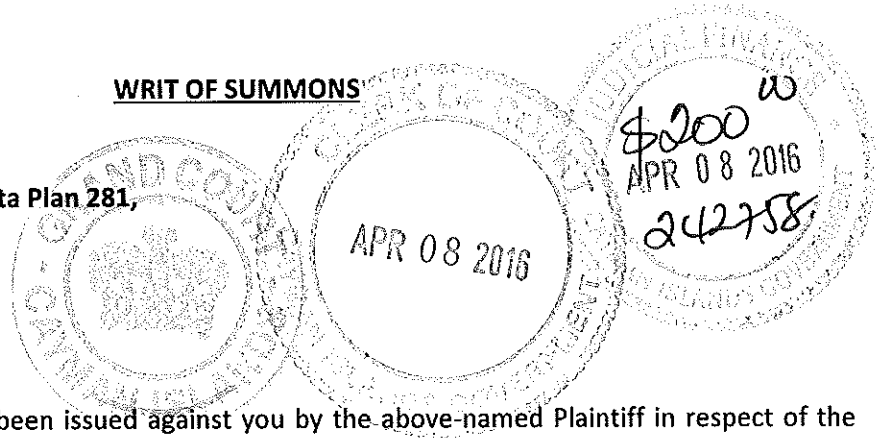

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.


STATEMENT OF CLAIM

1. The Plaintiff is a Company registered under the Laws of the Cayman Islands, Carrying on the business of Construction Contractors.
2. The First Defendant is a Strata registered under the Strata Law.
3. The Second Defendant at all material times is and was the Manager of The First Defendant.
4. Between September 2014 and November 2015, the Defendants by Contract employed the Plaintiff to carry out construction Works at and on the Defendants Strata Premises.
5. The agreed price between the Plaintiff and the Defendants for the Construction work performed by the Plaintiff was the sum of CI\$ 126,877.60.
6. The Defendants paid the Plaintiff the sum of CI\$ 95,158.19 towards the sum of CI\$ 126,877.60 for the said contracted work leaving a balance of CI\$ 31,158.19 to be paid by the Defendants to the Plaintiff.
7. The Defendants agreed with the Plaintiff that they would pay the balance of CI\$ 31,158.19 for the Contracted work. However, notwithstanding numerous request by the Plaintiff to the Defendants to pay the said outstanding balance, the Defendants refuse and continue to refuse to pay the same.

And The Plaintiff Claims:

1. The Sum of CI\$ 31,758.19
2. Interest on the said sum pursuant to statute from the date of Judgment until payment at the rate of 2 3/8% per annum
3. Cost
4. Such further or other Relief as the Court deem proper.
