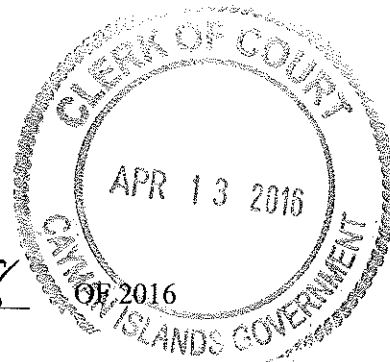

THIS PLAINT has been issued against you by the above –named plaintiff in respect of the claim set out on the next page.

If you fail to satisfy the claim or fail to return the Acknowledgement of Service Form containing full particulars of your defense, the Plaintiff may apply for **default judgment** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff resides at #370 West Bay Road, Seven Mile Beach.
2. The Defendant resides at 34 Greenwood Drive Prospect, Georgetown.
3. The Plaintiff claim against the defendant is for payment of the principal sum of CI\$5600.00 owed to him due to outstanding balance for damages to his rental Suzuki Liana motor car reg #155924

PARTICULARS

1. On Saturday 13th February, 2016 the Plaintiff and Ms. Shirley Jordan entered a written Contract on Thursday October 1st, 2015 for the Leasing of Suzuki Liana motor car #155924 in its present condition 10 years old for CI\$5000.00 or US\$6027.77. (See Attachment)
2. The agreement was that Ms. Shirley Jordan would pay a deposit of CI\$1500.00 upon entering the contract; thereon after Ms. Jordan would pay CI\$400.00 every month for nine months until her contract is finished.
3. On Saturday 13th February, 2016. Ms. Shirley's daughter Jordana Jordan who is an authorized driver for her vehicle #155924 had gotten into an accident by the traffic light on North Sound Road. Ms. Jordan's motor car Reg #155924 was struck from right front fender causing severe damage leading up to half of the front of the car which was caused by the Defendant who was driving Honda Acura Reg# 142453.
4. Ms. Jordan came out of the vehicle reg#155924 and met with the Defendant. Ms. Jordan then took out her cell phone and attempted to call her mother Ms. Shirley Jordan to inform her of the accident when the Defendant slapped Ms. Jordan's phone out of her hand not once but three times demanding her not to get anyone else involved.
5. An unknown witness called the police and PC#214 Emmanuel Brown attended the scene stated that the Defendant was at fault for the accident. Ms. Jordan then called her mother Ms. Shirley Jordan to come to the scene.
6. Ms. Jordan stated to PC#214 Brown that she was travelling along North Sound Road and went straight through an amber light passing Jacques Scott when the Defendant

who was coming from the opposite direction whilst turning right to go onto Shedden Road collided with her vehicle Reg#155924. The Defendant claims that Ms. Jordan was at fault as her light was on green.

7. Upon questioning the Defendant, PC #214 Brown noticed that the Defendant's vehicle License and Driver's License was expired and told her that she would be taken to the George Town Police Station. The Defendant in a state of panic pulled her pants down and urinated in the presence of PC#214 Brown. PC#214 Brown instructed both parties to report back to the Plaintiff's Office as soon as possible.
8. Ms. Jordan told her mother Ms. Shirley Jordan who arrived on the scene that her chest and her right ankle were in pain. Ms. Shirley took her to the George Town Hospital after PC#214 Brown had arrested the Defendant.
9. On Monday 15th February 2016, Ms. Jordana Jordan went to the Plaintiff's office filled out an incident report and also gave the Plaintiff a photo of Ms. Jordana at the Georgetown Hospital Accident and Emergency Department on Crutches with her ankle bounded and also receipts from the hospital.(See Attachments)
10. On Wednesday 17th February, 2016 Mr. Collin Redden who was the adjuster for the Plaintiff's vehicle Reg# 155924 looked at the vehicle which was towed to Andy's Auto to do an appraisal which the Plaintiff received on the Thursday 10th March, 2016. Mr. Redden's appraisal states that the Plaintiff's vehicle Reg#155924 was declared as an economical write off.(See Attachment)
11. On the Friday 19th February the Plaintiff received a towing invoice. (See Attachment)
12. On Wednesday 9th March, 2016 the Plaintiff called Ms. Earldene Omeria Gordon asking for a phone number for the Defendant as the Defendant had previously written off Ms. Gordon's rental Reg#156071 from the Plaintiff on Friday 13th November 2015. The Defendant took Ms. Gordon's rental Reg#156071 without her consent, wrote off the said vehicle and was arrested for DUI. Plaintiff obtained a phone number for the Defendant from Ms. Gordon.
13. On Wednesday 9th March, 2016, The Plaintiff called the Defendant to come in to fill out the paperwork. The Defendant stated that she would come in on this day as she has a very flexible schedule however she did not come. The Defendant allowed the Plaintiff to use Whatsapp as an alternative means of contact for her. The Defendant also applied for a police report on this day(See Attachment)
14. On Tuesday 15th March, 2016 the Plaintiff called the Defendant once again asking her to come in. The Defendant said she would come by but she did not show up.

15. On Tuesday 22nd March 2016, The Plaintiff messaged the Defendant via Whatsapp asking her to come in. The Defendant is receiving the messages but is not responding. The Plaintiff has also sent out a message to the Defendant on Tuesday 29th but no response. (See Attachment)
16. On Wednesday 30th March 2016 the Defendant messaged the Defendant via Whatsapp asking her to come in. The Defendant replied that she would try to come in but didn't show up.
17. On Thursday 31st March,2016 the Defendant messaged the Plaintiff via Whatsapp asking the time that the Plaintiff closes his Office which the Plaintiff did respond to the Defendant informing her that the rental location on Seven mile Beach closes at 5:00pm and that he was not in office until the following day from 8:00am to 1:00pm. The Defendant that she will try her best to come in between that time.
18. On Wednesday 6th April, 2016 the Plaintiff messaged the Defendant via Whatsapp asking her to come in on Thursday 7th April or Friday 8th April, 2016 but the Defendant didn't respond.

AND the Plaintiff claims:

1. The sum of CI\$5350.00
2. Fixed cost of CI\$250.00
3. Alternative cost to be assessed.
