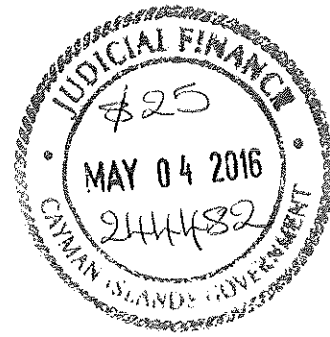

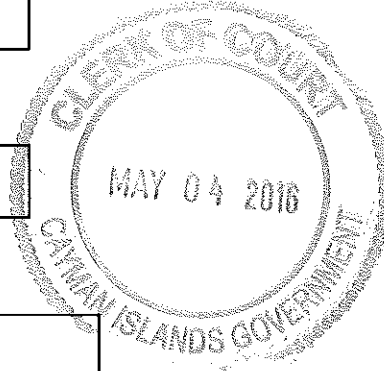

### PARTICULARS OF CLAIM
