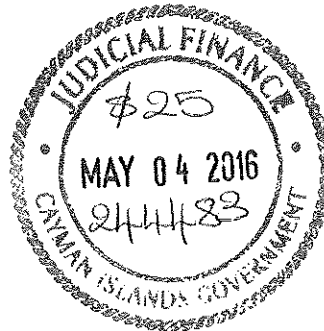

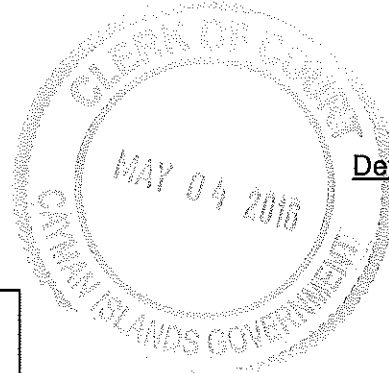


## PARTICULARS OF CLAIM
