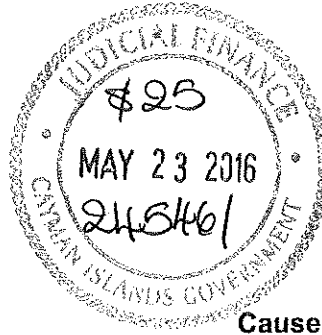

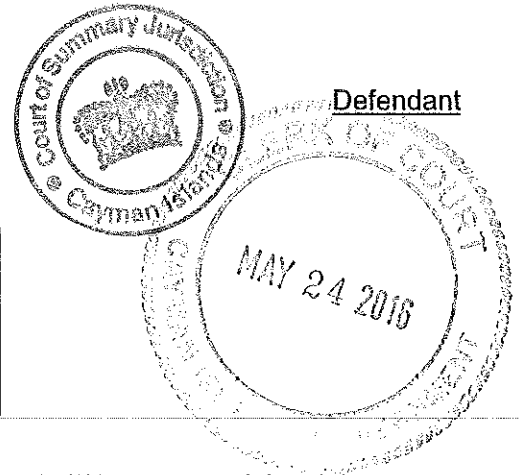

PARTICULARS OF CLAIM
