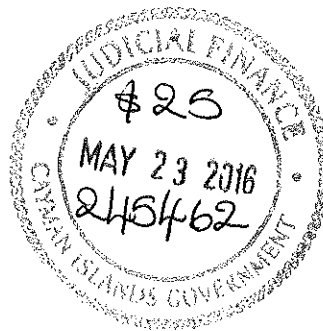

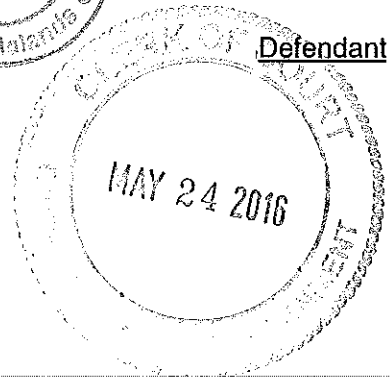

PARTICULARS OF CLAIM

1. Miss. Heather Tucker was issued a loan of CI\$400 on the 6/3/2015 for a payment term of two weeks.
2. Miss. Tucker did not pay on her due date and subsequently her payments were never made on time or in full causing her to fall delinquent.
3. Miss. Tucker signed a payment plan on the 17/7/2015, the plan was for her to pay \$200 on a bi-weekly basis, she did so only twice. The CIDCB also tried to have her come in and make payments, she made minimal payments totalling only \$324.00 and that is over a one year period.

AND the Plaintiff claims:

- 1 The sum of \$2442.00
- 2 Interest in the sum of \$53.72 calculated at the prescribed rate from 23/5/2016 to date.
- 3 Interest to continue until the matter is settled.
- 4 Fixed costs of \$ 150.00, alternatively costs to be assessed.
