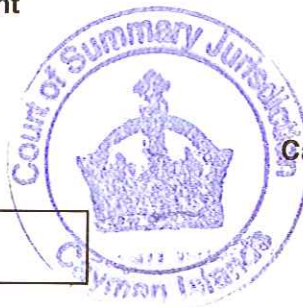

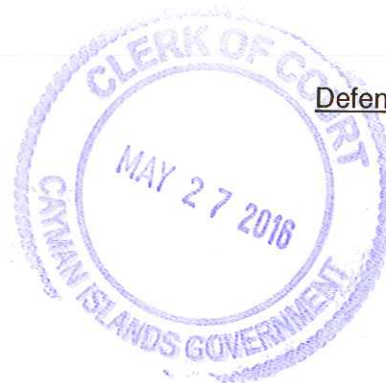

PARTICULARS OF CLAIM

1. Mr. Scott was issued a loan of \$300 on the 23/1/2015 his original due date was on the 29/1/2015, for an interest of \$45.00
2. He made a few payments, however he has never paid in full nor on time, this has caused him to fall delinquent.
3. We have made every effort to have him come in and pay off his loan including giving him a payment plan option. To date he has refused to honour that agreement.
4. He currently owes us a total of \$1800. This total includes principal and interest. His loan was calculated at 15% on each \$100 per two week payment term. A cap was placed on his loan since mid-2015, all payments has been calculated and adjusted accordingly.

AND the Plaintiff claims:

- 1 The sum of \$300.00
- 2 Interest in the sum of \$ 1500 calculated at the prescribed rate from 23/5/16 to date.
- 3 Interest to continue until the matter is settled.
- 4 Fixed costs of \$ 150.00, alternatively costs to be assessed.
