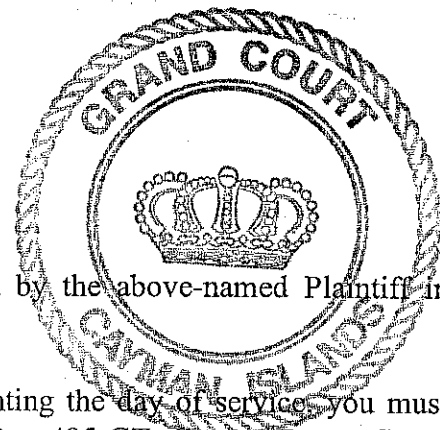

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P. O. Box 495 GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.


## STATEMENT OF CLAIM

1. The Plaintiff claims CI\$4380.38 from the Defendant for Fees in respect of survey done on Little Cayman .
2. On 30<sup>th</sup> April 1997 the Defendant incurred Fees in the amount of CI\$4380.38 in respect of a survey provided by the Lands & Survey Department for three parcels of land located in Little Cayman West, Block 80A Parcel 87, 88 and 97.
3. This debt became due and payable at the time the services were rendered.
4. The Lands & Survey Department wrote to the Defendant on two occasions requesting payment.
5. The Treasury Debt Collector wrote to the Defendant on 23rd, June, 1997 requesting payment but this debt remains unpaid.

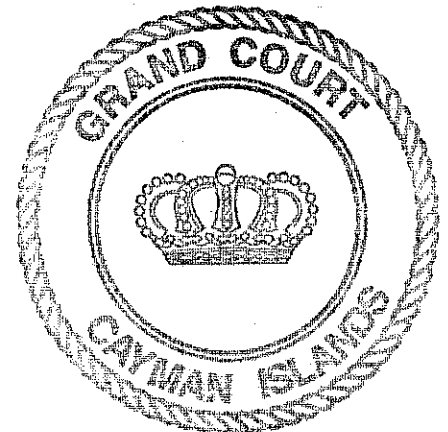
AND THE PLAINTIFF claims:

1. The sum of CI\$4380.38.
2. Interest at the statutory rate of 7 3/8%.
3. Fixed cost of CI\$150.00, alternatively costs to be assessed.

If, within the time for returning the Acknowledgment of Service, the Defendant pays the total amount claimed further proceedings will be stayed. The money must be paid to the Plaintiff.
