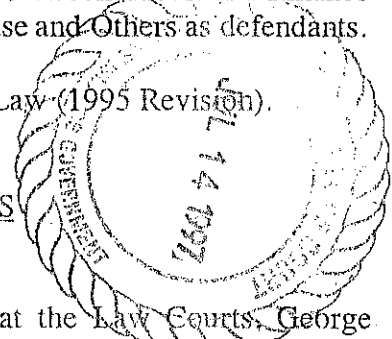

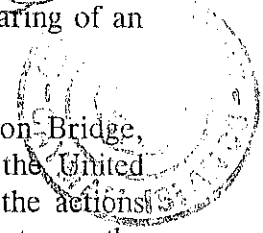

EX PARTE ORIGINATING SUMMONS



LET all parties concerned attend before the Judge in Chambers at the Law Courts, George Town, Grand Cayman on the 7th day of July, 1997 at 9:30 o'clock on the hearing of an application by -

1. the persons listed in Schedule 1 hereto of Southwark Towers, 32, London Bridge, London SE1 9SY who were partners or were held out to be partners of the United Kingdom Firm of Price Waterhouse at the times material to some or all the actions referred to in the title to this Originating Summons (hereinafter referred to as the "English Actions");
2. Mr. M.E. Austen and Mr. R. Allan of Southwark Towers, 32, London Bridge, London SE1 9SY who are defendants in certain of the English Actions and who are wrongly alleged to have been partners of the United Kingdom Firm of Price Waterhouse at the times material to those actions;
3. the persons listed in Schedule 2 hereto who were the partners of the North Caribbean Firm of Price Waterhouse of British American Centre, P. O. Box 258, George Town, Grand Cayman at the times material to some or all of the English Actions;
4. Price Waterhouse Societe Anonyme (formerly Price Waterhouse Societe Civile) of 24-26 Avenue du La Liberte, L-1930 Luxembourg;
5. the persons listed in Schedule 3 hereto who were associe of Price Waterhouse Societe



Civile (being on the Memorial) at times material to one or more of the English Actions;
and

6. the persons listed in Schedule 4 hereto who are wrongly alleged in the English Actions to be associe of Price Waterhouse Societe Civile (not being recorded on the Memorial) at times material to one or more of those actions.

The Applicants are now and/or will in the future be required to give in evidence confidential information belonging to one or more of the ICIC entities (as defined in the affidavit of Paul Louis Hainsworth) and/or their customers by means of producing documents by way of inspection pursuant to orders for discovery and/or requests made under RSC Order 24 in the English Actions.

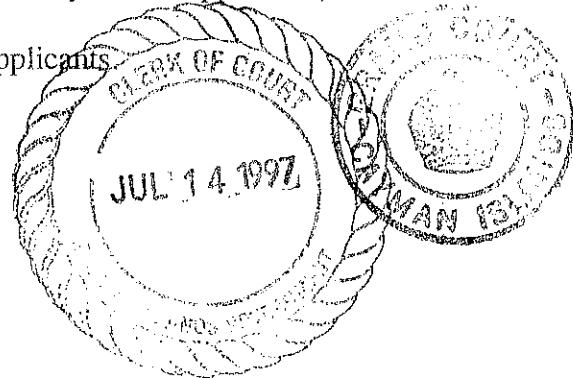
The Applicants intend to give in evidence confidential information belonging to the ICIC entities and/or their customers by means of such affidavits, written statements and oral testimony as they may consider appropriate in defence of the said actions.

And the Applicants seek a direction pursuant to Section 4 of the Confidential Relationships (Preservation) Law (1995 Revision) that they be permitted to give in evidence in the English Actions any confidential information belonging to any ICIC entity or any customer of any ICIC entity by means of:-

1. the production of documents pursuant to any request or order made under RSC Order 24;
2. any affidavit or witness statement served by or on behalf of any of the Applicants; and
3. any oral testimony given by or on behalf of any of the Applicants.
