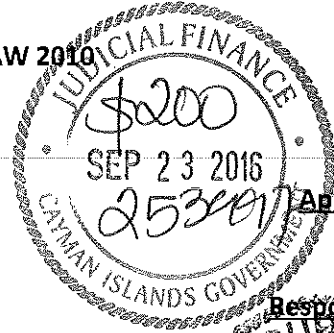
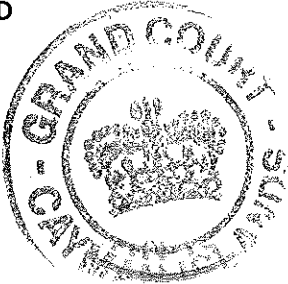

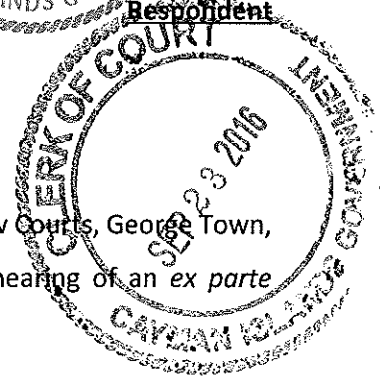

EX PARTE ORIGINATING SUMMONS

LET ALL PARTIES attend before a Judge of the Grand Court in Chambers, at the Law Courts, George Town, Grand Cayman, on the ^{13th} day of ~~Sept~~ October 2016, at 9:30 o'clock, on the hearing of an *ex parte* application by the Applicant for Orders that:



1. Pursuant to Section 5 of the Protection from Domestic Violence Law 2010, the Respondent by himself, his servants, agents or otherwise is prohibited from:
 - (a) Using or threatening violence against the Applicant and/or the children of the marriage;
 - (b) Assaulting, threatening, abusing, molesting, harassing or otherwise interfering with the Applicant and/or the children of the marriage;
 - (c) Communicating with the Applicant and/or the children of the marriage in any way;
 - (d) Approaching or coming within 150 feet of the Applicant and/or the children of the marriage;
 - (e) Entering, attempting to enter or coming within 150 feet of the Applicant's home at 63 Almond Avenue, Prospect, Grand Cayman;
 - (f) Damaging or attempting to damage any property which he knows or believes to belong to the Applicant.
2. Pursuant to Section 10 of the Protection from Domestic Violence Law 2010, the Applicant shall occupy the property at 63 Almond Avenue, Prospect, Grand Cayman and the Respondent shall be excluded from that property until further order.
3. Pursuant to section 6 of the Protection from Domestic Violence Law 2010, the police are directed to serve the *ex parte* orders on the Respondent and upon doing so, to remove the Respondent from the property referenced at paragraph 2 above.
4. A penal notice is attached to the orders set out in paragraphs 1 and 2, above.

This Ex Parte Summons is filed by Samson & McGrath, Attorneys-at-Law on behalf of the Applicant, whose address for service is 5th Floor, Genesis Building, Genesis Close, PO Box 446 GT, Grand Cayman, KY1-1106, Cayman Islands.


5. The matter be listed for an *inter partes* hearing with a time estimate of 1 hour. If the Respondent fails to attend or to be represented at that hearing the Court will consider making a final order in the terms set out above.

6. This order shall remain in force until the conclusion of the *inter partes* hearing.
