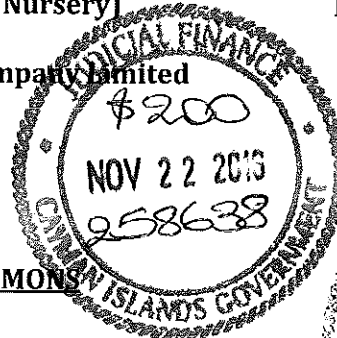

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledge of Service stating therein whether you intend to contest these proceedings.

If you fail to supply the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 22nd day of November 2016.

STATEMENT OF CLAIM

1. The Plaintiff is a business operating plant nursery business operating and providing/supplying goods and services out of #2470 Shamrock Road, Bodden Town, Grand Cayman, Cayman Islands.
2. The 1st Defendant is a company incorporated in the Cayman Islands dealing in the development of real-estate properties. The 2nd Defendant, the sole director and shareholder of the 1st Defendant and was at material times the operator or the 1st Defendant. The business postal address of P.O Box 1009, Grand Cayman, KY1-1001 was the billing address of the 1st and 2nd Defendants. The 1st and 2nd Defendant are collectively referred to herein as "the Defendants."
3. From in or around 25 November 2014 until in or around November 2015, the Plaintiff supplied plants and nursery services to the Defendants. On each occasion that a good or service was supplied at the request of the Defendants, an invoice would be issued by the Plaintiff to the Defendants (and in both names of the Defendants) for payment of said goods and/or services provided to the Defendants.
4. The invoices in question (attached), remain outstanding and unpaid as at the date of this Writ.
5. At the date of this Writ the principle sum outstanding is CI\$21,754.30.
6. The Plaintiff's previous attorney, Murray & Westerborg Attorneys at Law sent a letter to the Defendants, attached, dated 5th October 2015 requesting payment of the outstanding sum.
7. The 2nd Defendant responded by way of letter dated 19th October 2015 to the Plaintiff's previous attorneys and accepted the debt outline above existed, indicating the debt would be settled in November or December 2015. The debt was not settled as indicated.
8. In or around February 2016 the Plaintiff contacted the 2nd Defendant by email indicating that they had not received any of the outstanding monies and requesting advisement of payment terms. No response was received.
9. On 11 July 2016 attorney for the Plaintiff, H. Phillip Ebanks, wrote to the Defendants setting out, once again, the particulars of the debt owed and requesting payment to be made. The letter was served on the registered office of the 1st Defendant on the 15th July 2016.
10. On the 15th July 2016, a representative on behalf of Esters Trust (Cayman) Ltd, formally Appleby Trust Ltd, notified the attorney for the Plaintiff that they no

longer provided registered office services for the 1st Defendant pending an application to strike off the said company.

11. The 2nd Defendant was eventually personally served with this letter before action on the 29th August 2016 due to difficulties in service. The 2nd Defendant had successfully evaded personal service until this date.
12. On the 12th September 2016, the 2nd Defendant contacted the offices of the attorney for the Plaintiff indicating he would place an offer to repay in writing shortly.
13. On the 20th September 2016, the 2nd Defendant responded by email indicating that the amount of debt was not in dispute, nor was the fact that the debt existed. The 2nd Defendant further indicated he would be content to meet to discuss a schedule of repayment. Despite promises on the 12th September 2016 no such offer of repayment of the debt in formal terms was provided.
14. A letter was sent by the attorney for the Plaintiff dated the 10th September 2016 requesting the Defendants do provide a schedule of payments to clear the debt and sign a promissory note if requested. Said letter further requested a charge is registered over properties the 1st Defendant held. Said letter requested a response within 7 days. No such response was received.
15. On the 2nd November, the attorney for the Plaintiff received an email from the 2nd Defendant indicating that he would be in a position to provide further details within a week concerning realistic dates to repay.
16. The Defendants have had approximately 12 months to settle this debt and have failed to do so. The Defendants have repeatedly indicated a willingness to provide a schedule of repayment and have failed to do so.
17. In the circumstances the Plaintiff now seeks payment of the debt owed amounting to the principle sum of CI\$21,754.30 in addition to the sums claimed below.
18. In the addition, given the nature of the debt owed and the failure to pay despite numerous promises to he same the Plaintiff seeks the registration of a charge over any assets held by the 1st Defendant and/or the 2nd Defendant.
19. The Plaintiff claims for the unpaid balance and interest thereon pursuant to the Judicature Law (2007 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.


STATEMENT REGARDING INTEREST

20. The Plaintiff seeks pre and post judgment interest from the date of issue of the Writ in accordance at 2 3/8% per annum on the unpaid balance until payment and in accordance with the Judicature Law (2007 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.
21. Interest is claimed from the 22 November 2015.
22. The amount of interest owing at the date of issue of this Plaint (22 November 2016) is CI\$516.66.
23. The amount of interest accruing each day following the issue of this Plaint is CI\$1.42.

And the Plaintiff Claims Against the Defendants:

1. The Principle Sum of CI\$21,754.30.
2. Interest in accordance with the Judicature Law (2007 Revision) and the Judgment Debt (Rates of Interest) Rules.
3. Costs to be taxed or agreed.
4. Filing and Bailiff Fees.
5. Any relief that this Honourable Court deems fit.

**DIRECTIONS FOR ACKNOWLEDGEMENT OF SERVICE
OF WRIT OF SUMMONS**

1. The accompanying form of Acknowledgement of Service should be completed by an Attorney on behalf of the Defendant or by Defendant if acting in person.

After completion it must be delivered or sent by post to the Law Courts, PO 495G, George Town, Grand Cayman.

2. A Defendant who states in his Acknowledgement of Service that he intends to contest the proceedings must also serve a defence on the Attorney for the Plaintiff (or on the Plaintiff if acting in person).

If a Statement of Claim is not endorsed on the Writ, the Defence need not be served until 14 days after a Statement of Claim has been served on the Defendant.

If the Defendant fails to serve his defence within the appropriate time, the Plaintiff may enter judgment against him without further notice.

3. A Stay of Execution against the Defendant's goods may be applied for where the Defendant is unable to pay the money for which any judgment is entered. If a Defendant to an action for a debt or liquidated demand (i.e. a fixed sum) who does not intend to contest the proceedings states, in answer to Question 3 in the Acknowledgment of Service, that he intends to apply for a stay, execution will be stayed for 14 days after his Acknowledgement, but he must, within that time, issue a Summons for a stay of execution, supported by an affidavit of his means. The affidavit should state any offer which the Defendant desires to make for payment of the money by installments or otherwise.

Notes of Guidance

1. Each Defendant (if there are more than one) is required to complete an Acknowledgement of Service and return it to the Courts Office.
2. For the purpose of calculating the period of 14 days for acknowledging service, a writ served on the Defendant personally is treated as having served on the day it was delivered to him.
3. Where the Defendant is sued in a name different from his own, the form must be completed by him with the addition in paragraph 1 of the words "sued as (the name stated on the Writ of Summons)".
4. Where the Defendant is a FIRM and an attorney is not instructed, the form must be completed by a PARTNER by name, with the addition in paragraph 1 of the description "Partner in the form of (.....)" after his name.
5. Where the Defendant is sued as an individual TRADING IN A NAME OTHER THAN HIS OWN, the form must be completed by him with the addition in paragraph 1 of the description "trading as (.....)" after his name.
