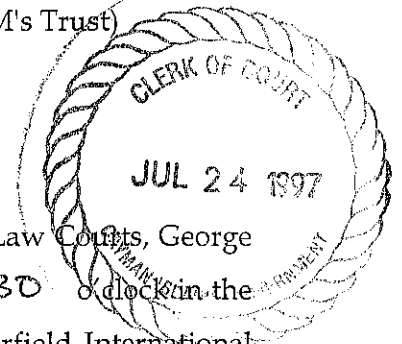

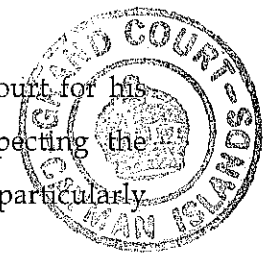

3. That such further and/or other opinion, advice or directions of the Court be given as may be appropriate.

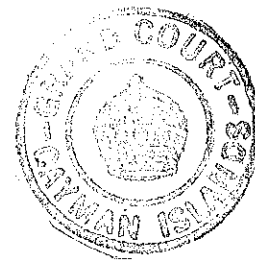
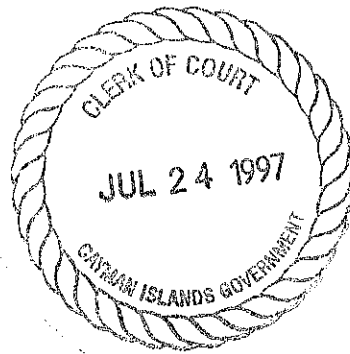
