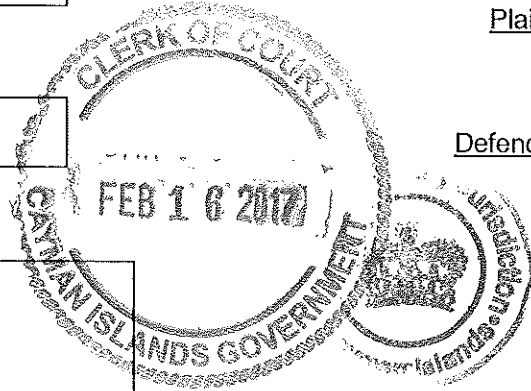

PARTICULARS OF CLAIM



- 1) On May 19, 2016 the Plaintiff paid the sum of CI\$1450 to the Defendant for the Purchase and installation of two new front seats and one new rear bench seat, inclusive of fitting brackets, and repainting the interior of the Plaintiff's Jeep Wrangler, registration 0111110.
- 2) Since that time only repair work and the repainting has been performed for agreed total value of CI\$350.
- 3) The Defendant has repeatedly misled the Plaintiff on the timing of the completion of the work
- 4) On January 30, 2017 the Plaintiff requested the balance of funds due (CI\$1075) to be returned. AND the Plaintiff claims: The Defendant has since that time failed to repay the Plaintiff.
