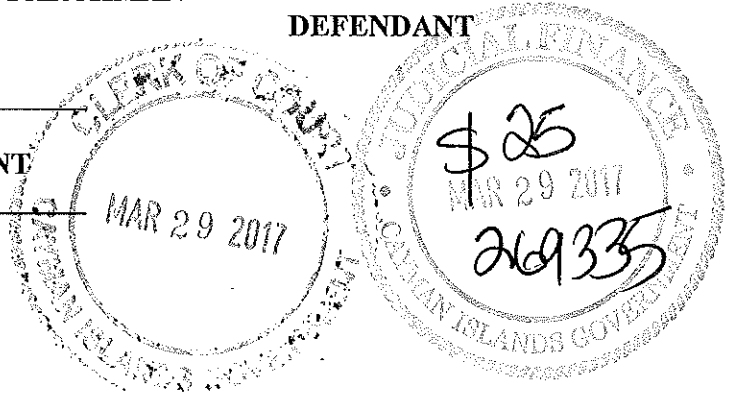

1. The Plaintiff is a Bank carrying on business at its branch at Elgin Avenue, PO Box 1097, George Town, Grand Cayman KY1-1102 and elsewhere, and the Defendant is and at all material times, has been a customer of the Plaintiff at the said branch.
2. The Defendant is currently indebted to the Plaintiff in respect of a Loan Account #014-14167 in the principal sum of CI\$14,217.39, together with interest of CI\$4,062.06 and late fees of CI\$750.00.
3. Interest continues to accrue daily until payment.
4. The Plaintiff has made written demand for repayment by letter from its attorneys but the Defendant has failed to repay the said sum.

**AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:**

1. Payment of the said sum of CI\$19,029.45;
2. Interest on the above principal sum at the rate of 9.25% per annum, and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
