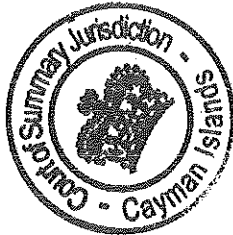

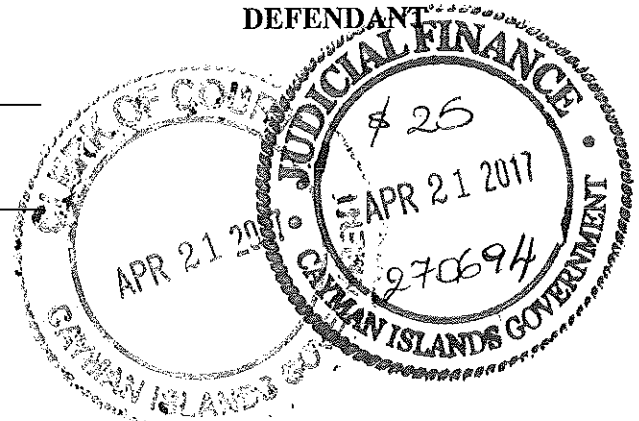

THIS PLAINT has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after service of this Plaint on you, counting the day of service, you must either satisfy the claim or return to the Court Office, PO Box 495, George Town, Grand Cayman KY1-1106, the accompanying Acknowledgement of Service form stating therein whether you intend to contest this action. If you intend to defend this action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the Acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

PARTICULARS OF CLAIM

1. The Plaintiff is a Bank carrying on business at its branch at PO Box 68, 25 Main Street, George Town, Grand Cayman and elsewhere, and the Defendant is and was at all material times, a customer of the Plaintiff.
2. The Defendant is currently indebted to the Plaintiff in respect of a Loan Account #10288448 in the principal sum of CI\$5,576.88, plus interest which will continue to accrue at the rate of 10.50% per annum until payment. The current arrears amount to CI\$632.00. The Loan Account is repayable on demand.
3. The Plaintiff has made written demand for payment of the arrears on the Loan Account by letter dated 8 March 2017 and served on the Defendant on the 8 March 2017 from its attorneys but the Defendant has failed to repay the said sum. The Plaintiff now seeks repayment of the full amount now due under the Loan Account.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said sum of CI\$5,576.88;
2. Interest on the above principal sum at the rate of 10.50% per annum, and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
3. Costs.
