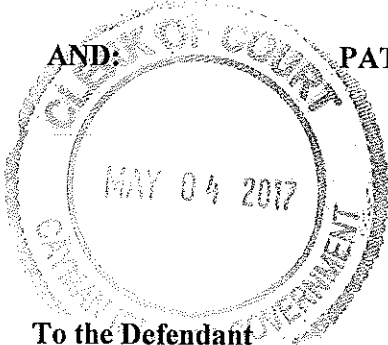

PARTICULARS OF CLAIM

1. The Plaintiff is a Bank carrying on business at its branch at PO Box 68, 25 Main Street, George Town, Grand Cayman and elsewhere, and the Defendant is and was at all material times, a customer of the Plaintiff.
2. The Defendant is currently indebted to the Plaintiff in respect of a Loan Account #10460873 in the principal sum of CI\$2,377.94, plus interest which will continue to accrue at the rate of 11% per annum until payment. The current arrears amount to CI\$699.24. The Loan Account is repayable on demand.
3. The Plaintiff has made written demand for payment of the arrears on the Loan Account by letter dated 8 March 2017 and served on the Defendant on the 8 March 2017 from its attorneys but the Defendant has failed to repay the said sum. The Plaintiff now seeks repayment of the full amount now due under the Loan Account.

AND THE PLAINTIFF CLAIMS AGAINST THE DEFENDANT:

1. Payment of the said sum of CI\$2,377.94;
2. Interest on the above principal sum at the rate of 11% per annum, and continuing until payment at the same rate pursuant to the Plaintiff's standard banking terms and conditions.
3. Costs.
