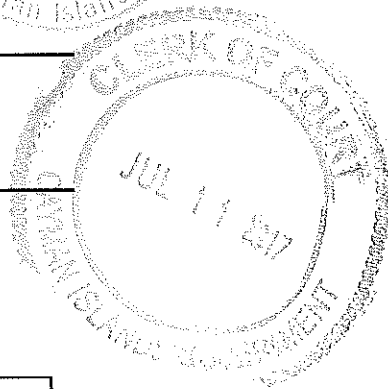
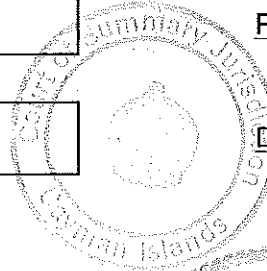

**THIS PLAINT** has been issued against you by the above – named Plaintiff in respect of the claim set out on the next page.

**Within 14 days** after service of this **Plaint** on you, counting the day of service you must either satisfy the claim or return to the Court Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the Acknowledgement of Service form.

**If you fail** to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

## PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

1. On 8<sup>th</sup> June 2017 the Grand Court issued an order from the Honourable Mr. Justice Williams related to Cause No. Fam 265 of 2010. Item 2 on page 5 of the order states that Tania Davies will pay Brynley Davies the sum of US \$13,305.66 by 7<sup>th</sup> July 2017, by providing a bankers draft.
2. On 7<sup>th</sup> July 2017 the Plaintiff's law firm for that matter, Solomon Harris, received a bankers draft for the sum of US \$12,149.46.
3. The Defendant has not complied with the terms of the order in place and should pay the Plaintiff the difference in the amount owed.
4. The Plaintiff is requesting that the court enforces the June 2017 order.
5. The Defendant should also pay interest at the prescribed rate on the amount outstanding as at the date of the Plaintiff as well as at the per diem rate until the amount outstanding has been paid in full.

AND the Plaintiff claims:

- 1 The sum of US \$1,156.20.
- 2 Interest in the sum of US \$0.31 calculated at the prescribed rate from 8<sup>th</sup> July 2017 to date.
- 3 Interest to continue until the matter is settled.
- 4 Fixed costs of CI \$175, alternatively costs to be assessed.
- 5 Any reasonable sum required to provide Service on the Petitioner.
