**THIS PLAINT** has been issued against you by the above – named Plaintiff in respect of the claim set out on the next page.

**Within 14 days** after service of this **Plaint** on you, counting the day of service you must either satisfy the claim or return to the Court Office, PO Box 495GT, George Town, Grand Cayman, the accompanying Acknowledgment of Service form stating therein whether you intend to contest this action. If you intend to defend the action, in whole or in part, you must set out **full particulars of your defence** in the space provided in the Acknowledgement of Service form.

**If you fail** to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defence, the Plaintiff may apply for a **default judgment** without any further notice to you.

### **PARTICULARS OF CLAIM**

1. The plaintiff is a body corporate formed pursuant to the Strata Titles Registration Law ("the Law") and is capable of bringing proceedings by virtue of section 5(1) of the Law.
2. The defendant is the registered proprietor of property West Bay North West, Block 4B Parcel 631H7 being a unit within the plaintiff strata.
3. Pursuant to Article 21(3) of the Law, the bye-laws set forth in Schedules 1 and 2 to the law are in force and by virtue of section 21(7) of the Law these bye-laws bind the owners of units at the plaintiff strata including the defendant and the plaintiff itself.
4. In accordance with section 1(d) of Schedule 1 it is the defendant's duty to make payment of all rates, taxes, charges, outgoings and assessments that may be payable in respect of his property.
5. The plaintiff levied charges and assessments against the defendant's property for contributions for administrative expenses and in breach of the written bye-laws, the defendant failed or refused to pay the sum of CI\$3,670.70 between 1<sup>st</sup> October 2010 and 1<sup>st</sup> July 2017 which is still due and owing. Full particulars of the sum of CI\$3,670.70 is set out in the statement annexed to this plaint.

#### **Statement regarding interest**

The Plaintiff seeks pre and post judgment interest from the date of issue of proceedings at the rate of 2 3/8% per annum on the unpaid balance until payment and in accordance with the provisions of the Judicature Law (2013 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.

- b) The interest rate claimed is 2 3/8%.
- c) Interest is claimed on the sum claimed from the 18<sup>th</sup> July 2017.
- d) The amount of interest owing at date of issue of this Plaint is \$0.
- e) The amount of interest accruing each day following the issue of this Plaint is CI\$0.23.

#### **AND THE PLAINTIFF CLAIMS:**

- (i) The said sum of CI\$3,670.70 as monies due and owing.

- (ii) Pre and post judgment Interest on the said sum in accordance with the the Judicature Law (2016 Revision) and the Judgment Debt (Rates of Interest) Rules as amended from time to time.
- (iii) Costs or alternatively fixed costs in the sum of CI\$500.00 plus filing fees and bailiff's fee for service
