
PARTICULARS OF CLAIM

1. **The Plaintiff rented a Motor Vehicle from the Defendant, a contract was signed to the agreement of the Rent a Car.**
2. **The M/V was rented on June 15 2016 and was returned on January 15 2017 and at the time the outstanding bill was \$6,167.18**
3. **The Defendant paid \$4,351.60 and promised to pay said balance of \$1815.58.**
4. **An agreement was made with the defendant with a debt collection agency to pay \$1,712.09 at \$200.00 per month starting effective 30 March 2017 and ending September 2017. Two payments of \$200.00 were made and one payment of \$100.00. Several efforts were made to contact the defendant without success.**
5. **From April to September simple interest 0.5%per month in the amount of CI\$35.96.**
6. **As of September 4, 2017 The Defendant owes the Plaintiff the Principal sum of CI\$1,048.05**

AND the Plaintiff claims:

- 1 Judgment for the principal sum CI\$1,048.05
- 2 Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$100.00 for service pursuant to Summary Court Rule alternatively costs to be assessed.
- 3 Total sum CI\$1,323.05
