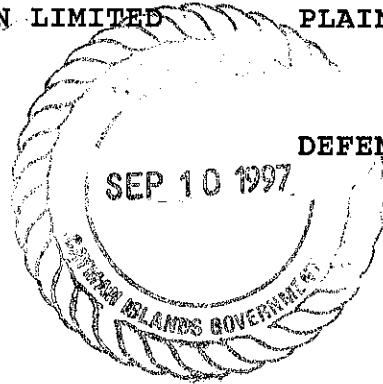

STATEMENT OF CLAIM

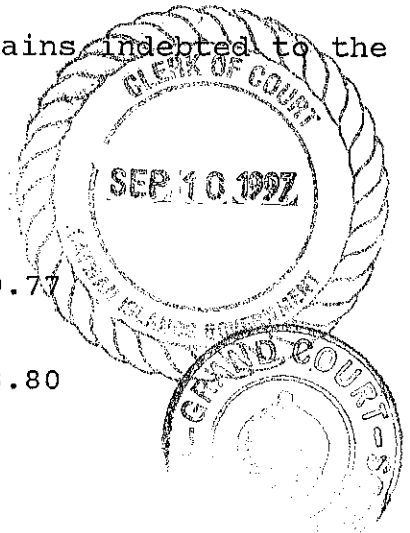
1. By an Agreement in writing made the 29th May 1996 between the Plaintiff and the Defendant, it was agreed that:-
 - (1) the Plaintiff would advance to the Defendant a loan in the sum of CI\$8,511.39;
 - (2) The Defendant would repay the loan by 42 monthly instalments of CI\$249.42;
 - (3) Interest would be charged at one per cent per month on the unpaid balances due and payable monthly;
 - (4) In the case of default in payment the entire balance of the loan shall become immediately due and payable;
 - (5) The Defendant will pay all costs and expenses incurred in the collection of any sum due.

2. By a demand dated 14th August 1997, the Plaintiff by it's Attorneys, Messrs Ritch & Conolly, made demand on the Defendant in the sum of CI\$2,119.77 together with interest thereon at the daily rate of CI\$0.69 the Defendant having made default in payment.

3. As at the date hereof the Defendant remains indebted to the Plaintiff in the sum of CI\$2,133.57.

Interest thereon at 0.69 per day
from 14/08/97 to 03/09/97 CI\$13.80



AND THE PLAINTIFF CLAIMS:

1. The said sum of CI\$2,133.57.
2. Interest thereon pursuant to contract in the sum of CI\$0.69 per day from the date hereof until Judgment or sooner payment. Alternatively interest at such rate and for such period as the Court may direct pursuant to
3. Costs on an indemnity basis pursuant to Contract.
