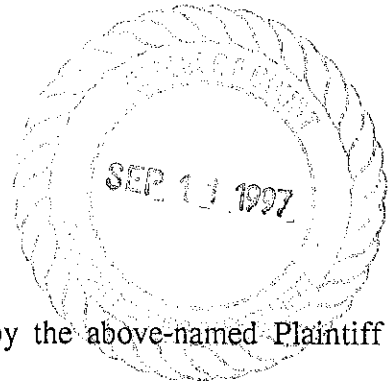

THIS WRIT OF SUMMONS has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within 14 days after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgment of Service stating therein whether you intend to contest these proceedings.

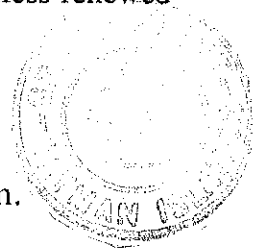
If you fail to satisfy the claim or to return the Acknowledgment within the time stated, or if you return the Acknowledgment without stating therein an intention to contest the proceedings, the Plaintiff may proceed with the action and judgment may be entered against you forthwith without further notice.

Issued this 9th day of September 1997.

NOTE - This Writ may not be served later than 4 calendar months (*or, if leave is required to effect service out of the jurisdiction, 6 months*) beginning with the date of issue, unless renewed by order of the Court.

INDORSEMENT

1. By a deed dated 30 May 1995, in consideration of the Plaintiff making an advance to one Hospitality Technical Services Ltd. ("Hospitality") the Defendant agreed with the Plaintiff to guarantee the due payment of the same together with interest at the rate of 9.25% per annum up to the sum of CI\$25,000.00.
2. From the said date the Plaintiff has made advances to Hospitality and the amount outstanding to the Plaintiff presently exceeds CI\$69,000.00.
3. Demand under the said guarantee was made of the Defendant by letter dated 20 May 1997.
4. Neither Hospitality nor the Defendant has paid the sum owing to the plaintiff.

**AND THE PLAINTIFF CLAIMS:-**

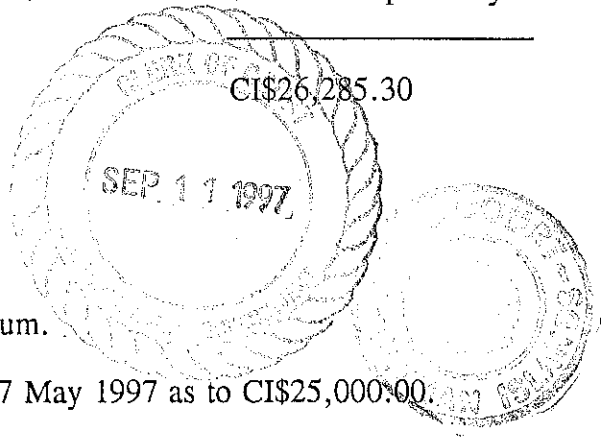
1. AN ORDER for the payment by the Defendant of the sum of CI\$25,000.00.
2. INTEREST accrued to 9 September 1997 under The Judicature Law at the rate of 7 3/8% per annum.
3. FURTHER and/or other relief.
4. Fixed Costs and the Prescribed Filing Fee of CI\$500.00 and CI\$250.00 respectively.

Total Amount as of 9 September 1997:

CI\$26,285.30

**STATEMENT REGARDING INTEREST:**

1. The rate of interest claimed is 7 3/8% per annum.
2. The date from which interest is calculated is 27 May 1997 as to CI\$25,000.00.
3. The total amount of interest claimed as at 9 September 1997, is CI\$535.30.
4. The amount of interest accruing each day thereafter is CI\$5.05.



If, within the time for returning the Acknowledgment of Service, the Defendant(s) pays the total amount claimed of CI\$26,285.30 (including interest and costs) further proceedings will be stayed. The money must be paid to the Plaintiff's Attorney.
