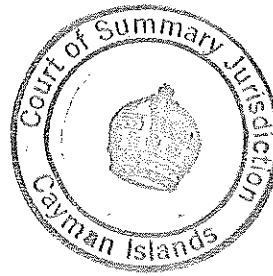

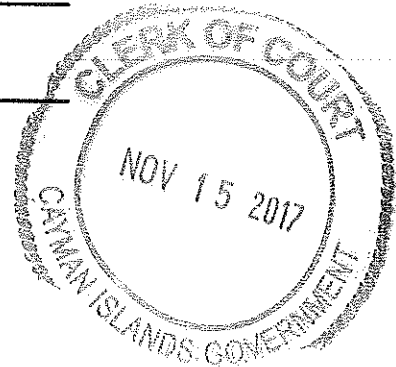

If you intend to defend the action, in whole or in part, you must set out **full particulars of your defense** in the space provided in the Acknowledgement of Service form.

If you fail to satisfy the claim or fail to return the Acknowledgement of Service form containing full particulars of your defense, the Plaintiff may apply for a **default Judgment** without any further notice to you.


PARTICULARS OF CLAIM

(Here set out in numbered paragraphs the grounds upon which the Plaintiff claims that the Defendant is indebted to him or is liable to pay damages to him)

- 1 The Defendant started renting motor vehicles from the Plaintiff in 2015.
- 2 Between 2015 and May 2016 the Defendant rented three different vehicles. All the contracts were signed and the Defendant agreed to pay such.
- 3 The last rental the Defendant did was May 28 2016 to which the Defendant agreed to bill the outstanding bill.
- 4 After one year of no payment the Defendant was contacted concerning her outstanding bill and a promissory agreement was made between the Defendant and the Plaintiff.
- 5 The Defendant broke the signed promissory agreement and a debt collector was hired to collect said debt.
- 6 The Defendant still refused to pay the Plaintiff
- 7 As of November 7 2017 the Plaintiff claims that the Defendant owes \$1,363.00

AND the Plaintiff claims:

- (1) The sum of \$1,363.00
- (2) Interest in the sum of \$300.00 calculated at the prescribed rate from January 2016 to date.
- (3) Interest to continue until this matter is settled.
- (4) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (5) Total sum \$1,963.00
