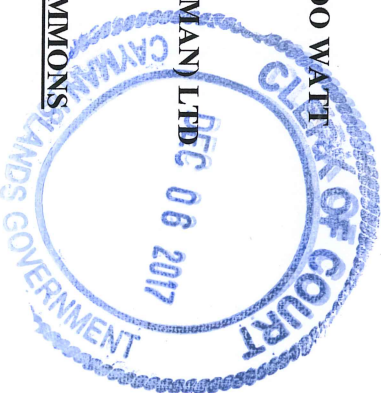

WRIT OF SUMMONS


TO: Scotia Centre, Cardinal Avenue, P.O. Box 689, Grand Cayman, Cayman Islands.

**THIS WRIT OF SUMMONS** has been issued against you by the above-named Plaintiff in respect of the claim set out on the next page.

Within [14 days] after the service of this Writ on you, counting the day of service, you must either satisfy the claim or return to the Court Office, P.O. Box 495G, George Town, Grand Cayman, the accompanying Acknowledgement of Service stating therein whether you intend to contest these proceedings.

If you fail to satisfy the claim or to return the Acknowledgement within the time stated, or if you return the Acknowledgement without stating an intention to contest the proceedings, the Plaintiff may proceed with the action and judgement may be entered against you forthwith without further notice.

AND THE PLAINTIFF claims:

1. Immediate Cessation of sale of my property at **Registration Lower Valley Block 38B Parcel 544** valued at Cayman Islands Two Hundred and Ten Thousand Dollars (CIS\$210,000.00), as this sale was enacted by applying grossly unfair and unethical Banking practices.
2. Compensation for approximately five (5) years of inhumane torture that Scotiabank & Trust (Cayman) Ltd put me through by:
  - a) not honouring their promise to ease my burden with a re-finance that I was qualified for.
  - b) For dragging me to Court on 10<sup>th</sup> January, 2017 on erroneous and false information (Affidavit of James Pollard – Senior Valuer with Bould Consulting Ltd ( Cause No. 213).
  - c). For preventing me from paying on my mortgage and then stating afterwards that ‘the Bank had gone ahead and sold my property because I had made no further effort to pay.
  - d). For quoting me an erroneous, fictitious mortgage arrears balance that was even more than what the figure was prior to my last payments.

3. I am respectfully requesting justice to be served by this Honourable Court by Awarding me full, free and clear ownership of my property at Registration Lower Valley Block 38B Parcel 544 or compensation as this Honourable Court sees fit that be fair and just to make up for the unreasonable hardships that I had borne.

If, within the time for returning the Acknowledgment of Service, the Defendant honours the claimed of free and clear ownership of his property without prejudice or come to a reasonable agreement with the Plaintiff, further proceedings will be stayed.

In the case of a limited company, "residence" means its registered or principal office.
