PARTICULARS OF CLAIM

- 1 In November 2016 The defendant signed a contract with the Defendant to advertize the business of Champion House (exhibit 1)
- 2 The total charge was \$15,000.00 and a discount was given leaving a balance to pay of \$6,142.50.
- 3 The Plaintiff paid \$2,770.50 leaving an outstanding balance of \$3,372.00. The last payment received was February 20, 2017.
- 4 As of September 2017 the Plaintiff made numerous phone calls to the Defendant concerning payment with no success.
- 5 In November 2017 the Plaintiff hired a debt collector to collect the monies owed. A demand was sent to the Defendant on November 2 2017 to which the Defendant refused or failed to acknowledge.
- 6 After the demand letter was sent the Plaintiff tried again to contact the Defendant with no success as the Defendant continued to hang up the phone
- 7 As of December 13, 2017 the Plaintiff claims \$4,046.00 plus interest of \$786.00 @.05%

AND the Plaintiff claims:

- (1) The sum of \$4,046.00
- (2) Interest of \$786.00 as stated in paragraph (7)
- (3) Fixed costs of \$150.00, \$25.00 filing fee and process server fee \$125.00 alternatively costs to be assessed.
- (4) Total sum \$5,132.00
